This is my first year as your LCIF Coordinator for OH5 so it will definitely be a learning process for me. With PCC Dave as the State LCIF representative I'll be in good hands though. But I'm sure my reports will be more refined than PCC Dave's.

The State LCIF District Coordinators met with PCC Dave Risen, MD13 State Coordinator, for our first LCIF ZOOM meeting of the year in July. We discussed several issues to get all the newbies started including our upcoming training to be held in Atlanta next month. Many did not yet have access to the portal so the issue of getting information about LCIF reports was at the top of the list.

We discussed LCIF Grants, Recognition, and Legacy Programs so everyone was aware of all LCIF resources available to us and where to access all information at our disposal.

We discussed assisting clubs with MJF and PMJF as well as speaking to clubs about LCIF. I have a presentation about LCIF that I can present to any club who needs a speaker and would like to have me to come and talk to their club about LCIF.

We are looking for ideas and suggestions for a Multiple District LCIF Fundraising project for this Lions year.

As everyone knows, Texas have been the biggest topic with LCIF's "Disaster Relief Fund" and donations have been requested in support of the Texas disaster. In OH5 we've have 4 donations come directly through me (or via PCC Dave through me), totaling \$1,800. This doesn't include donations made directly through LCIF that we weren't made aware of or haven't yet seen.

The latest report from LCIF as of July 23rd shows Clubs in total supporting LCIF for a total of \$81,437.48 so far this Lions year.

I will be attending Zone meetings and making personal visits to many of our District Clubs in the promotion and encouragement of this LCIF fundraising opportunity as I am able with my other duties.

It is my commitment to continue to ask for the support and assistance of both the district leadership as well as the Zone Chairs in support of LCIF. I will be reporting throughout the Lions year our annual donations and will be in communication with each of our District Clubs and leaders as well as Club LCIF Coordinators in the promotion of LCIF.

I want to thank PCC Dave Risen for his confidence in selecting me for this position. Hopefully I can do as well as he did.

SUBJECT: 1st Quarter State LCIF Committee Report

Council Chairperson Brad & Council of Governors:

It is both an honor and privilege to be appointed by LCIF as the Multiple District LCIF Coordinator for this Lions year.

In addition, I am both honored and privileged to work for and with the seven LCIF District Coordinators that all were just recently appointed by LCIF.

I personally want to welcome those new LCIF District Coordinators to include IPDG Susan Davis of OH-1, Lion Erin Stewart-Arness of OH-4, PDG Jackie Miller of OH-5 and Co-Coordinators PDG Richard and Ollie Tipple.

The State LCIF Committee met on Sunday, July 20, 2025, via Zoom format. All the LCIF District Coordinators attended this Zoom meeting. CC Brad King and Committee Liaison DG Faith Cataldo-Gauger were also in attendance.

After a formal introduction to the new and previously appointed District LCIF Coordinators was presented, a brief discussion regarding the LCI Lions portal and the importance of navigating the portal to include obtaining numerous report features.

PCC Risen presented a brief review of the "Drilldown Report" to include LCIF total donations, goal percentage, member participation, club participation and snapshot of 2025-2026.

PCC Risen informed the Coordinators of the LCIF "Tool Kit" availability to include a vast assortment of online training information and forms availability.

PCC Risen encouraged District Coordinator Zone and Club visits during this lion's year. Informed the Coordinators of the availability of expense account reimbursement of \$750.00 this current lion's year.

PCC Risen presented a brief discussion regarding LCIF Grants to include DCG Grant Programs, Grant history print materials and LCIF Grant Toolkit weblink.

Discussion regarding LCIF recognitions and assisting lions, clubs, and District leadership with MJF and PMJF recognitions.

PCC Risen provided an overview of the Lions Legacy Program and encouraged Coordinators to inform District Lions of this program.

A brief presentation by each District Coordinator of the goals and objectives and plans they have in place as the focus of LCIF financial support will be at the forefront.

PCC Risen requested that the LCIF District Coordinators present a new Multiple District LCIF fundraising initiative and provide a recommendation at our next meeting.

PCC Risen informed the Coordinators of the Strategy Session that will take place in Atlanta, Georgia from September 5-8, 2025, and that those who plan to attend have been registered by LCIF per Lora Snow.

After some discussion regarding whether the committee should meet monthly or quarterly, it was decided based on full agreement that the State LCIF Committee meets every other month.

PCC Risen affirmed this request and recommended that these meetings take place via Zoom format and that the committee meet in person during the fourth quarter at the Ohio Lions State convention.

Comments were presented by CC Brad and PCC Risen thanked him for attending.

PCC Risen affirmed his constant support and assistance to the coordinators and expressed his full cooperation.

Each coordinator was given a moment to express any issues or concerns that they may have.

PCC Risen to send to all coordinator's information regarding the Lions portal, current LCIF related reports and LCIF new promotional information.

The next State LCIF Committee meeting is preliminary scheduled for Sunday, August 24, 2025, by Zoom format.
