Our District has 2 devices for vision screening. If given a weeks' notice, I can deliver one of the units to any club interested in hosting a vision screening event. Clubs can contact me or Jackie Miller to reserve dates/equipment.

I am working with the Prevent Blindness Ohio to set up training for our clubs to allow for training in the Ohio public schools. This training includes free equipment that is approved by the State of Ohio for public school use.

PBO's FREE Children's Vision Screening Training Program meets the standards published by the National Center for Children's Vision and Eye Health and is approved by the Ohio Department of Health.

Participants who successfully complete all aspects of the training may be eligible to receive free vision screening equipment.

Through a grant awarded by the Ohio Department of Health (Save Our Sight Fund), Prevent Blindness, Ohio Affiliate offers free evidence-based training, certification and equipment for the July 1, 2023 - June 30, 2024 period for individuals who screen children in preschool through twelfth grade.

We have three modalities through which we provide this training: Virtual (self-paced), Live Virtual and In-Person.

If you are interested in participating in our children's vision screening training, the first step is for you to register for the training by clicking on one of the training registration links below. Once you have registered, we will review your responses to verify your eligibility to participate in our training pursuant to our grant guidelines and deliverables. We will then get back with you.

I will be briefing on this as part of new business in February's cabinet meeting.

I have been working on vision screening training at various clubs to promote Sight and Hearing as a service activity. I also plan on utilizing the Pride report, visiting clubs and zone meetings to promote Sight and Hearing.
