# Tidbits from 19E District Administration Assistant PDG Harry Lippincott

As we reach the end of the 1<sup>st</sup> half of the Lions year and the end of the calendar year, I am providing suggestions for Club Secretaries and Club Treasurers to undertake in January.

#### Membership (Secretary and Treasurer)

In mid-January your Club Treasurer will receive a dues billing statement. Included with that statement will be listing of the current members as recorded at LCI. It is recommended the Secretary and Treasurer review that member list to assure those listed are the members currently active in the club and that the club is not paying dues for dropped or deceased members.

Additionally, for Club Secretaries this review presents a very good time to update each member's information as shown on the web site. That information is current mailing address, phone numbers, email address, etc. You get the point.

#### **Dues (Treasurer)**

Working with the Secretary use the list of members that you will receive from LCI. Rationale explained above. Do not forget that LCI dues billing means that when billed the dues are due. That basically means by the end of January.

New for this 2<sup>nd</sup> half billing from MD19 will an increase in dues that was voted in at the MD19 Annual Convention in October in Wenatchee. I have copied the schedule for the dues increase below. I recommend the Club Treasurer keep a copy of the schedule readily available.

During the 98th Annual MD19 Annual Convention, delegates voted to increase the per member club assessment. That increase was based upon a recommendation that passed at the spring 2019 Council of Governors meeting. The minutes of that meeting can be found here:

https://lionsmd19.org/downloads/minutes-2019-spring.pdf. The following chart clarifies how those numbers add up. Remember, clubs will be invoiced based upon the LCI membership as of December 31 and June 30 of the Lions fiscal year. The assessment is due payable to MD19 by February 28 and August 31. Please note this chart only reflects the assessment by MD19, LCI will charge separately. At the end of this assessment cycle in July 2026/2027 members will be paying US \$0.75 per month more than they are currently paying.
