Candidate Qualifications For District Governor, 1st and 2nd Vice District Governors are found in the LCI International Constitution & By-Laws - By-Law ARTICLE IX – District Conventions and Elections

A candidate for the office of District Governor shall: (Refer to LCI By-Law ARTICLE IX Section 4. Candidacy Requirements For District Governor.)

- (a) Be an active member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
- (b) Secure the endorsement of his/her club or a majority of the clubs in his/her single or sub-district.
- (c) Currently be serving as the first vice district governor within the district from which he/she is to be elected.
- (d) Only in the event the current first vice district governor does not stand for election as district governor, or if a vacancy in the position of first vice district governor exists at the time of the district convention, any club member who fulfills the qualifications for the office of second vice district governor as set forth in the LCI International by-laws or constitution and who is currently serving or who has served one (1) additional year as a member of the district cabinet, shall fulfill the requirements of subsection (c) of this section.

A candidate for the office of 1st Vice District Governor shall: (Refer to LCI By-Law ARTICLE IX Section 6(b). Candidacy Requirements For The Office Of First (1st) Vice District Governor.)

- 1) Be an Active Member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
- 2) Secure the endorsement of his/her club or a majority of the clubs in his/her single or sub-district.
- 3) Currently be serving as the second vice district governor within the district from which he/she is to be elected.
- 4) Only in the event the current second vice district governor does not stand for election as first vice district governor, or if a vacancy in the position of second vice district governor exists at the time of the district convention, any club member who fulfills the qualifications for the office of second vice district governor as set forth in these by-laws or constitution shall fulfill the requirements of subsection (3) of this section.

A candidate for the office of 2nd Vice District Governor shall: (Refer to LCI By-Law ARTICLE IX Section 6(c). Candidacy Requirements For The Office Of Second (2nd) Vice District Governor.)

1. Be an Active Member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
2. Secure the endorsement of his/her club or a majority of the clubs in his/her single or sub-district.
3. Have served or will have served at the time he/she takes office as second vice district governor:
 - a) As president of a Lions club for a full term or major portion thereof, and a member of the board of directors of a Lions club for no less than two (2) additional years; and
 - b) As zone chairperson or region chairperson or cabinet secretary and/or treasurer for a full term or major portion thereof.
 - c) With none of the above being accomplished concurrently.
4. Has not completed a full term or major portion thereof as district governor.

A Candidate for the office of Region or Zone Chairperson shall: (Refer to the District A-4 Constitution, By-Law Article II Section 7.)

- (a) Be an active member in good standing in his/her respective region or zone; and
- (b) Have served or will have served at the time of taking office as region or zone chairperson as:
 - President of a Lions club for a full term or major portion thereof, and
 - A member of the board of directors of a Lions club for no less than two (2) additional years.
- (c) Have not previously served a full term or a major portion thereof as district governor
- (d) Zone and region chairpersons may serve no more than three (3) cumulative years in said position.
