Special Olympics Minnesota – A Special Opportunity to Serve for Lions!

Special Olympics helps people with intellectual disabilities develop confidence and social skills, though sports training and competition. Besides competitions, year-round training activities help enhance not only the physical health, but the emotional well-being of the programs' participants.

The mission of Special Olympics Minnesota is to offer children and adults with intellectual disabilities year-round sports training and competition. Through Special Olympics athletic, health and leadership programs, people with intellectual disabilities transform themselves, their communities and the world!

Lions Clubs International is the Global Partner of Special Olympics-Lions clubs International Opening Eyes initiative, giving both financial and volunteer support.

Indeed, many Lions are aware of Special Olympics, and some are already involved in the organization's activities. And beyond what many are aware of, the actual physical training and competition there's more – recognizing that proper training is only a part of an athlete's well-being. Screenings are offered – at no charge to the athletes or their families – in a variety of areas, including Vision (Opening Eyes), Audiology (Healthy Hearing), Dentistry (Special Smiles), Podiatry (Fit Feet), Sports Physical Exams (MedFest), Physical Therapy (FUNfitness), and Better health and well-being (Health Promotion).

As a Lion, you can help! There are numerous ways to be of service to Special Olympics Minnesota, including not only the obvious financial contributions, but donating one's time at various events.

In the case of financial contributions, a club member can earmark their donation to be applied to a specific geographical region, simply by noting this location on their check. Further, contributions submitted through Lions clubs will be 100% allocated to Special Olympic operations, in contrast to those submitted 'from the outside,' which are typically split between operations and (approximately 17%) administrative functions.

In addition to giving money, members have the opportunity to volunteer with their local delegations – or independently – as coaches for one or more sports. Each sporting session lasts for approximately eight weeks. There are also opportunities to serve as a mentor for an athlete (this requires a 2-year commitment). Alternatively, one can volunteer for a specific event at the area, regional or state competition. These usually involve 4-hour shifts. Generally, signing up as a volunteer is done directly with Special Olympics Minnesota: their website is http://specialolympicsminnesota.org/get-involved/become-a-volunteer/. In some cases, a background check is required. Any questions about volunteering may be directed to Jay Pedersen at Special Olympics Minnesota, 612.604.1267.

If you'd like to contribute, you may do so at any time – any amount is welcome! Please make your check payable to Special Olympics Minnesota with a specific geographic area noted on the memo line of the check (these are Special Olympics MN areas; to find out which applies please contact me), and send to Lion David Stein, 703 9th St. NW, Buffalo, MN 55313. Special Olympics Minnesota is recognized by the IRS as a §501(c)(3) organization.

Centennial Service Challenge to our 5M7 Lions Clubs

The Lions Club International (LCI) will be 100 years old on June 7, 2017. That's the June day in 1917 when LCI first began. They didn't have their first national convention until later that year, in November of 1917. But Melvin Jones incorporated the organization on June 7th. So we are now less than two years away from that monumental occasion! It's time to "get crackin'".

In preparation for marking this 100" Anniversary, most of you have already heard that LCI has put forward a meaningful set of challenges to every club and district for each of the years 2015, 2016, 2017 and 2018. For each of these four years the International President has (or will) put forward a message emphasizing that all Lions engage in special activities directed toward four specialty areas: YOUTH, HUNGER, VISION and the ENVIRONMENT. While it is likely that most clubs are already engaged in club activities which qualify as activities directed to these four areas, some clubs may not be meeting the defining criteria.

So the first step is for each club president to take inventory of their club's planned annual activity listing, and ascertain whether or not their club is on the road to covering Youth, Hunger, Vision and Environment in each of the next four years. It is certainly expected that most clubs will implement four good activities and, as a minimum, simply repeat these each subsequent year.

What's in it for the individual Lion? The Centennial Celebration Membership Awards gives you the opportunity to be a part of our Centennial Celebration marking 100 years of Lions serving our communities. Lions can earn special awards in two ways: (1) sponsoring new members and (2) helping organize clubs. Just invite a new member or help organize a new club and be rewarded!

Earn the Diamond Centennial Lion Award once the new member or new club remains in good standing for 3 years and a day.


Earn the Gold Centennial Lion Award once the new member or new club remains in good standing for 2 years and a day.

HAVE YOU FILED YOUR FEDERAL TAX FORM FOR 2014-15?

Most Minnesota Lions Clubs qualify to file Federal tax form 990N (less than \$50,000 per year in gross receipts). This has to be filed online, and for most clubs it must be filed before **November 15** of this year (there are a few Lions Clubs that have a calendar year as their fiscal year and your club must file each year by May 15).

To file, the easiest way to do it is to go to the following website: http://epostcard.from990.org . Once you are at the site, you need to have the following:

Completing the e-Postcard requires the eight items listed below:

- Employer identification number (EIN), also known as a Taxpayer Identification Number (TIM). Your secretary should have this, or you can get it for your club on the LCI website, <u>www.mylci.org</u>, then pull up your club, it will have the number listed. This is a nine digit number.
- Tax year Use July 1, 2014 to June 30, 2015.
- 3. Legal name and mailing address
- 4. Any other names the organization uses
- Name and address of a principal officer
- Web site address if the organization has one
- 7. Confirmation that the organization's annual gross receipts are \$50,000 or less
- 8. If applicable, a statement that the organization has terminated or is terminating (going out of business)

You MUST complete this every year. If you miss for 3 year, your club loses its tax exempt status and you must pay a \$400 reinstatement fee to get re-registered (or more, if you have more than \$10,000 in donations made by the club, per year). Avoid the pain, make sure that this is done at the latest by November 15 of each year, but do it early in case there is some glitch that needs to be dealt with.

INSTRUCTIONS FOR ANNUAL CORPORATE FILING WITH THE MINNESOTA SECRETARY OF STATE

This needs to be done by all of the Minnesota clubs and districts by December 31 of each year.

The instructions for the annual filing for Minnesota Secretary of State for corporate status are as follows:

- On the internet, enter https://online.sos.state.mn.us/abr/corp_annual_filing.asp
- Enter entity File # that you received with the notice from the Secretary of State's office, and the entity type (NP – Non-Profit corporation) using the select button.
- 3. If entered correctly, click "continue"
- 4. Fill in the required information (President's name and address)
- 5. Click Submit Registration; click OK


