AGREEMENT

In consideration of the collaborative parties of the DR Marketing & Promotions, hereinafter referred to as the LESSOR, permitting the LESSEE to use the booth space rented, the LESSEE agrees to the following: 1. The LESSEE agrees to fully observe and comply with, and ensure compliance with all existing laws and policies herein which in any manner affect or relate to the use of the Rental Booth. 2. The Booth must be accepted as assigned. LESSEES are not permitted to remove and/or relocate the booth from the assigned spot without prior approval of the LESSOR. 3. It is the LESSOR's right to relocate the rental booth should it deem necessary. 4. The LESSEE will at all times preserve good order around the Rental Booth and will not permit or allow therein unlawful proceedings of any kind. 5. The LESSEE will be solely responsible for all losses, costs, damages and expenses of any kind whatsoever resulting from, arising out of, or incidental to the use of the Rental Booth. 6. The LESSEE will remove its property and clean up all rubbish or waste material in or around the Rental Booth by 5:00 p.m. of October 15, 2011. 7. Subletting and Assignment: The LESSEE may not sub-let any portion of the Booth space nor otherwise assign this Agreement, without the prior written consent of the LESSOR. 8. The LESSOR reserves the right to inspect the products being offered for sale by the lessee, and restrict the sale of any item it feels is in violation of existing federal, state and local laws and ordinances. 9. The LESSOR reserves the right to evict anyone violating any of the rules outlined herein, or violating any other rules and regulations governing the event. 10. Booths are rented for the duration of event only. Rental shall begin at 8:00 a.m. and end at 4:00 p.m. on October 15, 2011. No cancellations or rentals will be allowed after October 8, 2011. 11. Rental payments must be made by check, money order or cash payable to "DR Marketing & Promotions". Receipts will be issued after payments are made. 12. Termination and Default: Should the premises not be available or be destroyed or damaged to such an extent that such destruction or damage will substantially interfere with the use of the premises as intended, or should a labor dispute or some other occurrence prevent the intended usage in the manner provided, then the LESSOR shall have the right to terminate this Agreement, apportion rental costs where applicable, and refund the balance of the rental fee, if any. 13. The LESSOR reserves the right to change, cancel or add any rule or rules at any time for any reason whatsoever, and to move, relocate, suspend operating privileges, or immediately terminate this agreement without prior notification to anyone. 14. Legal Recourse: If any legal action or proceeding be brought by either party to enforce any part of this Agreement, the prevailing party recovers, in addition to all other relief, reasonable attorney's fees and costs. 15. Indemnity: LESSEE shall conduct its activities within the premises so as not to endanger any person lawfully thereon and agrees to indemnify and hold harmless the LESSOR, its officers, employees, agents and contractors of any nature whatsoever as a direct and proximate cause of Lessee's activities. 16. WAIVER: LESSEE hereby agrees to waive any liability against LESSOR, Paradise Valley Hospital, the City of National City, the County of San Diego and the State of California for any loss or damages arising from theft, weather conditions, other damages or occurrences beyond the control of the LESSOR.
