## IRS FILING REQUIREMENTS

Several years ago the IRS started to require all tax exempt organizations to file annual tax returns. This was done to cut down on and stop the phony use of tax exempt status. It is now time to file your return for the 2010- 2011 fiscal year. As you know, the Lions fiscal year runs from July 1 through June 30th. Returns need to be filed with the IRS no later than November 15th following the end of the fiscal year. If your club follows the calendar year as your fiscal year, than your return should have been filed by April 15th. Which form you must use for filing your return has changed from last year's return. The new requirements are as follows:

- 1. Form 990 N (e-postcard) for clubs having gross receipts less than \$50,000. Last year's requirement was less than \$25,000.
- 2. Form 990 EZ for clubs having gross receipts from \$50,001 to \$200,000 and having assets less than \$500,000. Last year's requirement was \$25,001 to \$99,999 and assets of \$1.25 Million
  - 3. Form 990 for clubs with gross receipts in excess of \$200,000 and assets over \$500,000.

These clubs must also include a professional audit with their return. Last year's requirement were \$100,000 in receipts and \$1.25 million in assets. As you can see the IRS has increased the allowable receipt limits but lowered the asset limits. Gross receipts are defined as all monies coming into the club without subtracting your expenses. For most clubs this is not a problem but could be for those clubs that own any property. Most of the District's clubs will use form 990 N e-postcard. To file is simple in the search part of your homepage type in filing form 990N choose one of the search options or type in the following http://epostcard.form990.org/ This address takes you to filing page. Once there just follow the instructions. You will need your clubs EIN (Employer Identification Number) to file your return. If you don't know it, just go to the bank and ask. If you have more than one EIN you must file a return for every number or cancel the numbers you don't use. One thing that you will notice, as you are completing the return is that the name of the Organization is Lions Clubs International; your club name will not appear. This is because International has registered all known club EIN numbers under its umbrella to maintain the tax exempt status of all clubs. You will receive a confirmation e-mail once the IRS has accepted your return. Print this out and keep it with your 2010 -2011 financial records. If you have not filed a return in the past 2 years please do so this year. If you don't your club will lose its tax exempt status and must begin paying taxes. It is a long difficult process to regain your tax exempt status.

## CALL FOR INTERNATIONAL DIRECTOR CANDIDATES

At the State Council Meeting held in Harrisburg, PA on August 6th, 2011, the State Council of Governors took action to endorse a candidate for International Director at the 2012 International Convention in Busan, Korea. This candidate would be an advocate for Pennsylvania and Lionism on the International level. State Council is requesting all eligible districts with no less than 1250 members and 35 Lions Clubs to consider endorsing a candidate for this high office. (District 14-C qualifies but cannot nominate a candidate because the district will be hosting the State Convention in May 2012)

A candidate must meet the requirements for International Director as outlined in the Lions Clubs International Constitution & By-laws. "A candidate for the office of International Director shall:"

- Be an active Member in good standing of a Lions Club in good standing.
- Have completed or be completing a full term or major portion thereof as district governor of a full district of this association
- Secure the endorsement of a convention of his/her district. Provided, that the convention of the sub-district shall be eligible to endorse a candidate
- Secure the certification of endorsement of his/her district (sub and multiple) in accordance with the by-laws or constitution."

Interested candidates should send their resumes along with the endorsements of their club and district to the State Office no later than January 20, 2012. All qualified candidates should contact their district governor or the PA Lions State Office for further information.

This month we celebrate Lions World Sight Day and our commitment to saving sight around the world. This month I am also happy to share with you a new health initiative. I am sure you have heard of the deadly disease measles. The terrible truth is that 450 children die each day from this disease. You may not know that a devastating complication from this disease is blindness. This is just another reason that as Lions we join the fight to stop this disease to save lives and prevent childhood blindness.

Last year we joined the Measles Initiative, a collaborative effort of several leading organizations to eliminate measles. In less than 10 years, this August, the 1 billionth child was vaccinated through this initiative. While measles has been reduced by 78 percent since 2001, the World Health Organization estimates that decreasing support could result in 500,000 more deaths each year if the present progress rolls back to pre-2000 levels.

Our pilot year was a great success! Lions and our partners vaccinated 41 million children in four countries. Now we must expand these efforts to reach even more children in more countries. In a survey of Lions members, 90 percent expressed the desire to continue this program.

This is now possible thanks to a commitment by our partner, the Gates Foundation. The Gates Foundation is awarding us US\$5 million for the program this year, the largest single donation in our history. The Gates Foundation will do this by matching every US\$2 that we raise with US\$1. We have set a combined goal of providing U\$15 million toward this initiative.

## **River Blindness Eliminated in Colombia**

Since 2004, SightFirst has been a contributing partner in the Onchocerciasis Elimination Program of the Americas, which works to end the illness and transmission of onchocerciasis (or river blindness) in Latin America. As a result of health education and Mectizan® distribution, there has been no new blindness from onchocerciasis in these areas. The World Health Organization (WHO) will announce the elimination of onchocerciasis in Colombia at the Inter-American Conference of Onchocerciasis in November, making Colombia the first country to receive such certification.




