Recognizing that:

- The first objective of the International Association of Lions Clubs is to

Ereate and foster a spirit of understanding among people of the world

- The Lions of District 60 B and the communities they serve have basically the same aspirations and needs as the Lions and communities of the French West Indies and French Guyana forming District 63,
- Increasingly frequent contacts between individual Lions of the two Districts have been very cordial and have led to some genuine friendships and a desire to work closer together,

held exploratory talks in the fall of 2000 to consider the mutual interest in creating a stronger bond between the two Districts. They agreed on the following two-step process :

- A Initiate work on two joint projects to verify that language is not a barrier and that there is enthusiasm and a strong commitment at all levels to work closely together. The two projects selected are:
 - a) The creation of a joint Leo Club in St. Martin, bringing together quality young people from both sides of the Island,
 - b) Provide badly needed medical equipment and supplies to St. Jude Hospital in St. Lucia.

And later decide, from the feed-back of the Lions involved in these projects, where to go.

B -After reviewing the progress on these two projects and the degree of enthusiasm they generated among the Lions working together, the Governors decided to review it with their respective Cabinets and then proceed with the signing of this Twinning Convenant.

1) -The International Understanding and Cooperation Chairmen of the two Districts are hereby appointed as Administrators of the Twinning Convenant and must report on a quarterly basis, to the Governors on the joint activities.
