The Ohio Association of the Deaf/Blind is holding a 4-day retreat in Marengo, Ohio, on August 14 - 17, 2025. The retreat will include indoor and outdoor activities, plus a variety of workshops and classes to give attendees the tools they need to navigate in today's hearing/sighted world.

As you can imagine, this retreat will have huge costs associated with it and the OADB (a 501 (c)3 non-profit organization) is busy fundraising to cover their costs. They are reaching out to corporate donors as well as Lions for help.

Upcoming trios will be late April at the District 11-E-2 at Gaylord, Michigan and in early May at MD39 in Sun Valley, Idaho.



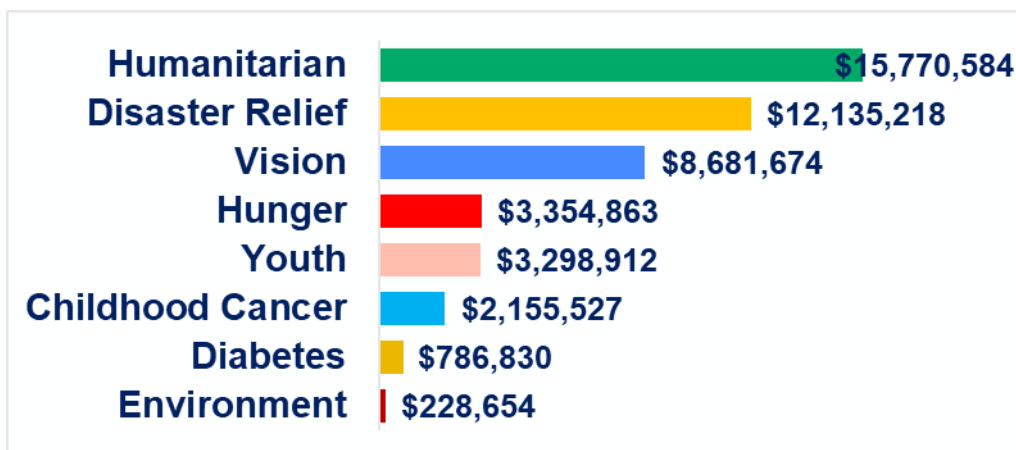

Grants Awarded by Cause Areas during FY 2023-2024



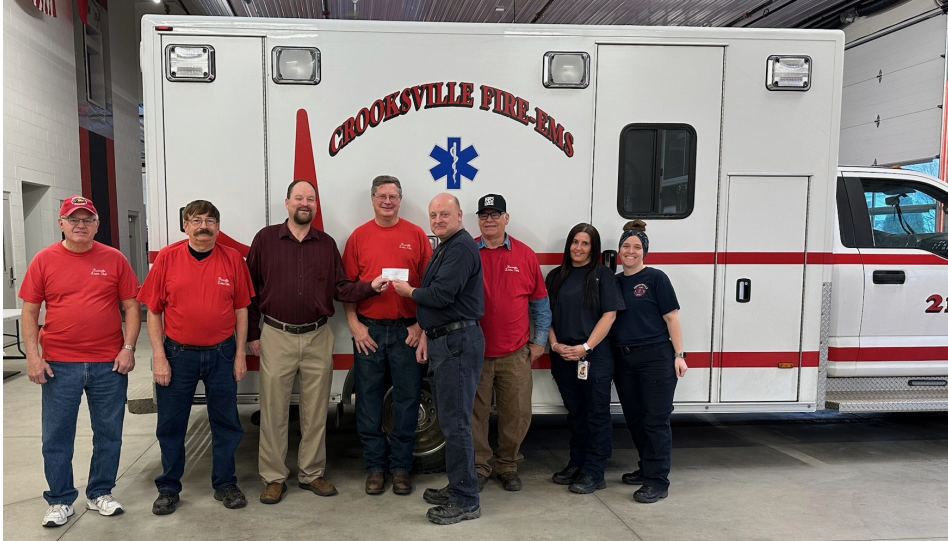

During the month of March, local Lions club members from several area clubs conducted preschool vision screening for select schools in Athens County at the request of Deb Richter (Athens Meigs Educational Resource Center).

Vision Screenings were conducted at the following schools:

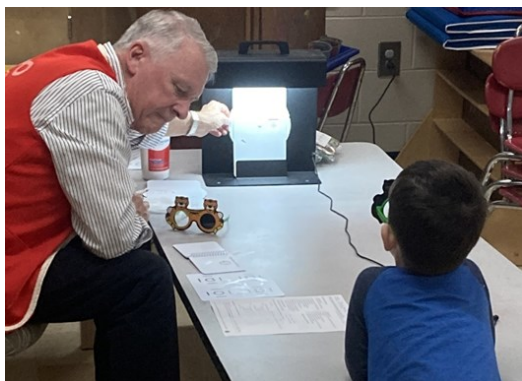
Alexander Elementary in Albany

Note: Additional testing will occur in the next few weeks for Morrison Gordon (Athens City), Amesville and Coolville Elementary schools (Federal Hocking) in Athens County.

Vision Screenings were performed in accordance with requirements dictated by the State of Ohio Department of Health (as described in training by Prevent Blindness Ohio). Screening included: visual observation of eyes for conditions and behaviors, ocular muscle balance, distance visual acuity by 5' crowded LEA symbol kit, distance visual acuity by PlusOptix autorefractor (not yet approved by State of Ohio Department of Health) and color deficit testing (for boys) using Good-Lite Color Check Pseudoisochromatic Color Vision Screening Plates. Note: when testing distance visual acuity using the 5' crowded LEA symbol kit, it is not necessary to evaluate children with the PASS-2 stereopsis test equipment.

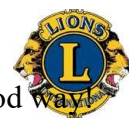

Compliance Isn't Just Paper work — It's Protection for Your Club

Within the last 5 to 10 years, oversight of Lions Clubs has become more comprehensive. There

are new requirements, or old requirements, now being enforced. The Attorney General's office

has employees that monitor social media posts looking for clubs violating state laws. It is time

Lions began paying more attention to these legal requirements, as well as legal protection for

our club and our members. As of March, 2025:

- 16 clubs appear to not have filed their 990 forms, whether full, 990-EZ or 990-N, with the IRS for the last tax year.
- 3 clubs have had their tax-exempt status revoked.
- 14 clubs haven't filed last year's report with the Attorney General's office.
- 17 clubs are not an incorporated non-profit in the state of Ohio, either because they have allowed their corporation charter to be cancelled due to not filing their Statement of Continued Existence or they have never filed to incorporate.

Many of us are not used to these requirements or the fact that there is government oversight now in place, but it is time to start paying attention. Please read the following to help you better understand what is required and how you can help protect your membership and officers.

Incorporation — It's Not Required, But It's Smart

Ohio doesn't require nonprofit community groups like Lions Clubs to incorporate. However,

incorporating with the Ohio Secretary of State gives your club legal standing as a nonprofit organization and provides limited liability protection for members.

That means if something ever goes wrong — a legal dispute, an accident at an event, or a financial question — your personal assets are less likely to be on the line.

Cost: \$99 (one-time); \$25 every 5 years thereafter for Statement of Continued Existence

Annual Filing with the Ohio Attorney General

Once you're operating as a nonprofit (whether incorporated or not), the Ohio Attorney General

wants to know what you're up to — in a good way.

Every club must file an annual report through the Charitable Registration Portal.

Due: Within 6 months of your fiscal year-end

Cost:

- \$0 if revenue is under \$25,000

- \$50 for \$25,000–\$50,000

* \$200 for over \$50,000

Don't Skip Your 990-N Filing with the IRS

If your club is recognized as a 501(c)(4) tax-exempt organization, the IRS expects to hear from you every year — even if you made zero dollars.

The form they want if your club has \$50,000 or less in annual gross income is called the 990-N (or e-Postcard), and it's very short.

Due: 15th day of the 5th month after your fiscal year ends (usually November 15 for clubs with a fiscal year of July 1 - June 30)

If you miss three years in a row, the IRS will automatically revoke your tax-exempt status.

Lost Your Tax-Exempt Status? Here's What to Do

If your club has lost its IRS tax-exempt status, don't panic — but don't ignore it either.

You'll need to file IRS Form 1024-A and pay the reinstatement fee. You'll also need to show a reasonable cause for why you didn't file.

One More Thing: BOI Filing May Apply

If your club's IRS tax-exempt status has lapsed, you may be required to file a Beneficial Ownership Information (BOI) report under the Corporate Transparency Act.

Due: Within 90 days of forming or losing exemption

File Here: <https://www.fincen.gov/boi>

Penalties: Up to \$500 per day if not filed — and potential criminal charges for willful noncompliance



Compliance Isn't Just Paperwork — It's Protection for Your Club...continues

LCI Action: In an email sent to Lions Club Leaders in December, 2024, stated the following:

Lions clubs that lose their tax-exempt status have 180 days from revocation by the IRS to file a CTA annual report. If your club has lost its tax-exempt status, it is your obligation to work with the IRS and determine how to obtain reinstatement of your tax-exempt status. **Failure to do so may result in loss of your club's charter.**

Why It All Matters

It may seem like a lot, but each of these filings and registrations protects your club, your members, and your mission.

Taking the time to do them right ensures your club is able to:

- Receive donations and grants
- Host raffles and fundraising events legally
- Avoid fines and legal trouble
- Maintain trust with your community

And most importantly — it keeps your focus where it belongs: **serving others.**
