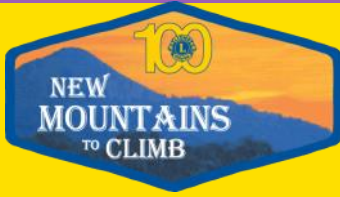

As you know we were trying to work something out with Amtrak as to having a train car for Lions to go to Chicago for the 2017 Convention.

As of this update we have filled the dedicated Lions Car on the train. However if anyone is still interested in riding the train you can go out on line to the Amtrak web at: www.amtrak.com/tickets-reservations and sign up. The train number we are taking is 8/28 leaving at 8:00AM on Thursday June, 29, 2017 and we will be returning from Chicago on train 7, leaving at 2:15PM on Wednesday July 5, 2017. District Governor Mike Janssen and Lions of District 5M11:

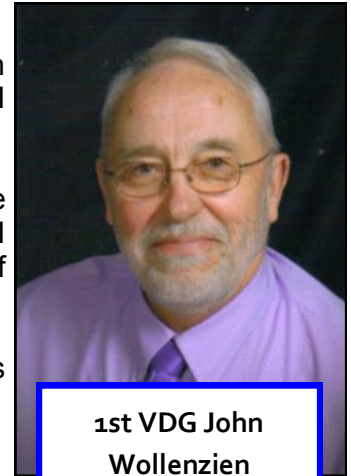
This is my letter of intent to seek the nomination for District Governor of Lions District 5M11 for the 2017-2018 term of office.

RESOLUTION 1 PDG Cheryl McKittrick

In the furtherance of the suggestion from the Board of Directors of the Lions Eye Bank of Manitoba and North West Ontario; and the Lions Foundation of Manitoba and Northwestern Ontario, that the District Governors of Lions Districts 5M-10, 5M-11, and 5M-13 be removed from the voting members of the board, the following resolution is presented to the members of the 3 Lions Districts affected:

- Whereas:** the District Governor has a very active workload during their year which includes visitations, administration of their District and the Multiple District among other duties,
- and **Whereas:** the operation of the Lions Eye Bank of Manitoba and North West Ontario; and the Lions Foundation of Manitoba and Northwestern Ontario has become more complex over the years since inception,
- and **Whereas:** the District Governor serves for only one year on the board,
- and **Whereas:** the District Governors of Districts 5M-10 and 5M-11 may be citizens of the United States and therefore less conversant with the details of the Canadian Medical system or the operation of the Lions Eye Bank of Manitoba and North West Ontario; and the Lions Foundation of Manitoba and Northwestern Ontario,
- and **Whereas:** attendance at the regular board meetings by the District Governors over the past three years has been sporadic causing the attainment of a quorum to become problematic,
- and **Whereas:** the board of directors of the Lions Eye Bank of Manitoba and North West Ontario; and the Lions Foundation of Manitoba and Northwestern Ontario value the input and advice of the District Governors in our deliberations,

Therefore, be it resolved that:

The official designation of the District Governor as a voting member of the board of directors of the Lions Eye Bank of Manitoba and North West Ontario; and the Lions Foundation of Manitoba and Northwestern Ontario be removed from the constitution, effective July 1, 2017

Also be it further resolved that:

The District Governor of Lions District 5M-10, 5M-11, and 5M-13, (or the designate of the District Governor from District 5M-10 or 5M-11, when that Governor is a resident of the United States), shall be entitled to receive notice of and may attend all meetings of the board of directors and may sit as an advisor during his/her year in office as District Governor. While at such meetings, he/she shall be allowed to express opinions and advice, however, shall not be allowed to vote on any matter which comes before the board, nor shall they be entitled to any reimbursement for any expenses incurred in respect of such attendance, effective July 1, 2017

Section 2: **DISTRICT GOVERNOR ELECTION PROCEDURES.** Any qualified member of a club in the district seeking the office of district governor shall file his/her intention to so run in writing with the Nominating Committee at least thirty (30) days prior to the start of the convention, and furnish evidence of his/her compliance with the qualifications for said office set out in the International Constitution and By-Laws. The Nominating Committee shall place in nomination at the district convention the name(s) of all candidate(s) so qualified. If none are so received and/or so qualified, then, but then only, nominations for the office may be made from the floor. A candidate shall be allowed one nominating speech of no more than five (5) minutes duration, and one seconding speech of no more than three (3) minutes duration.

Section 3: **FIRST AND SECOND VICE DISTRICT GOVERNOR ELECTION PROCEDURES.** Any member of a club in the district seeking the office of first or second vice district governor shall file his/her intention to so run in writing with the Nominating Committee at least thirty (30) days prior to the start of the convention, and furnish evidence of his/her compliance with the qualifications for said office set out in the International Constitution and By-Laws. The Nominating Committee shall place in nomination at the district convention the names of all candidates so qualified. If none are so received and/or so qualified, then, but then only, nominations for the office may be made from the floor. Each candidate shall be allowed one nominating speech of no more than five (5) minutes duration, and one seconding speech of no more than three (3) minutes duration.

*From the Constitution and By-laws of Lions Club International

A candidate for the office of district governor shall:

1. Be an active member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
2. Secure the endorsement of his/her club or a majority of the clubs in his/her single or sub-district.
3. Currently be serving as the first vice district governor within the district from which he/she is to be elected.

A candidate for the office of first vice district governor shall:

1. Be an active member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
2. Secure the endorsement of his/her club or a majority of the clubs in his/her single or subdistrict.
3. Currently be serving as the second vice district governor within the district from which he/she is to be elected.

A candidate for the office of second vice district governor shall:

1. Be an active member in good standing of a chartered Lions club in good standing in his/her single or sub-district.
2. Secure the endorsement of his/her club or a majority of the clubs in his/her single or subdistrict.
3. Have served or will have served at the time he/she takes office as second vice district governor:
 - a. As president of a Lions club for a full term or major portion thereof, and a member of the board of directors of a Lions club for no less than two (2) additional years; and
 - b. As zone chairperson or region chairperson or cabinet secretary and/or treasurer for a full term or major portion thereof.
 - c. With none of the above being accomplished concurrently.

MD5M Hall of Fame Award

Purpose

(October 2003)

To honor those Lion and Lioness members of character and substance who have demonstrated the highest level of commitment and dedication to the efforts of their club, district or multiple district and the motto of our association, "We Serve."

Award

There will be a maximum of one (1) recipient of the MD5M Hall of Fame Award per district, inducted into the MD5M Hall of Fame each year. The award may be presented posthumously

Exception: During the 2003-04, 2004-05 and 2005-06 Lion years, each district will be allowed two (2) Hall of Fame recipients, at least one (1) of which must be honored posthumously. Following the 2005-06 Lion year, beginning in the 2006-07 Lion year, the number of Hall of Fame recipients per district will return to one (1) per district.

The MD5M Hall of Fame award recipients are to be inducted into the Hall of Fame at the annual MD5M Multiple District Convention during the Saturday noon luncheon. The first honorees will be inducted May 21-23, 2004 at the MD5M Multiple Convention.

MD5M Hall of Fame recipients will receive a MD5M Hall of Fame award plaque and a Hall of Fame lapel pin in recognition of their induction in the MD5M Hall of Fame. In addition, a complete listing of all MD5M Hall of Fame recipients will appear in the annual MD5M directory and a perpetual plaque, with the names of all inductees and the year of their induction inscribed thereon, will be kept in a prominent place in the MD5M office, when available.

The presentation of the MD5M Hall of Fame inductees will be the responsibility of the current International Director from MD5M, if there is one and he/she is in attendance at the MD5M Multiple District Convention. If not, then the most recent Past International Director having served from MD5M in attendance at the MD5M Multiple District Convention.

Criteria

A candidate may be a Lion or Lioness, must have been a member in good standing for at least 15 years, be at least two (2) years removed from the Council of Governors if a PDG, should have qualifications above and beyond the call of duty including social and human endeavors, and he/she should be of good moral character and have a good reputation in his/her community. A nominee must be a member in good standing of a Lions or Lioness Club in MD5M, or must have been a member in good standing of a Lions or Lioness Club in MD5M at the time of their death.

Process

A candidate may be sponsored by any Lion, Lioness, Lions Club, Lioness Club, Zone, or District.

There will be a nomination fee of \$150.00 per each candidate nominated. The nomination fee will be returned to those sponsors whose candidates are not elected for induction into the MD5M Hall of Fame. The nomination fee for those selected for induction will be sent to MD5M and will be used to offset the cost of the award process, plaques and pin.

Nominations, including the nomination fee, must be received by the District Governor at least 30 days prior to the District's Mid-Winter Convention.

Each individual District will annually hold an election at their Mid-Winter Convention to determine the candidate(s), if any, to be inducted into the Hall of Fame for that Lion Year. Each sponsor will have an opportunity to give a brief presentation on the merits and biographical information of their nominee prior to the election. Those elected to be inducted into the MD5M

Hall of Fame will not be announced until their induction at the MD5M Multiple District Convention.

All nominations will use the standard form, no others will be accepted. The nomination fee must be received at the time the application is received, otherwise the nomination will not be considered.

All successful candidates will be inducted into the MD5M Hall of Fame at the next MD5M Multiple District Convention. The sponsor(s) and the respective District Governor will ensure that the honoree or a suitable representative be in attendance at the MD5M Multiple District Convention when the honorees are inducted.

A brief biography of each inductee shall be announced to those in attendance during the induction ceremony at the annual MD5M Multiple District Convention.

Lions Float, Inc Is a Support Group

Since 1994 Lions Float, Inc., a non-profit corporation, has taken charge of directing preparations and funding of the annual float. This year-round activity involves float design, fundraising and organizing and directing volunteers who work on the float decorations. In many cases these volunteers are composed of youth from our Leo clubs. And each year the International President and spouse add at least a few flowers during their visit.

Lions Float Inc. History

In 1992, under the leadership of then International President Donald E. Banker of Rolling Hills CA, Lions Clubs International entered its first float in the New Year's Day Tournament of Roses Parade in Pasadena and has continued every year since that time.

Two of our Lions entries (1993 and 1994) won awards for the most beautiful float in our category. However, we believe all our entries are winners since they present Lions with an opportunity to promote our service activities to people worldwide who watch the parade and see our float each year.

Lions Float, Inc., a non-profit corporation, was formed in 1994 to direct the preparation and funding of the Lions float in the Rose Parade. This is a year-round activity involving the designing, fundraising and coordinating of volunteer decoration of the float in December. To raise these funds, Lions Float, Inc. sells a variety of commemorative items such as pins, shirts, license plate frames, sun shades, antenna balls and hats and offers fellowships for donations honoring PIP Banker and others.

We welcome the support of Lions all over the world in supporting and decorating the float. What a better way to promote Lionism than to be represented in this widely publicized international parade. Lions International is the largest service organization in the world. ***We want the world to hear us ROAR!***
