He is also a Melvin Jones Fellow, a Helen Keller Fellow and a life member of the Arizona Lions Sight and Hearing Foundation.

Director Lundgren has three sons and 10 grandchildren. He is proud to say his family is a "three generation Lions family," with two of his sons, and their wives, and two of his grandchildren being Lions members.

Annual Electronic Notice (Form 990-N) for Small Organizations

The questions below relate to the requirement that small tax-exempt organizations file an annual electronic notice (Form 990-N, sometimes referred to as the *e-Postcard*).

1. Who must file Form 990-N (*e-Postcard*)?

Under the Pension Protection Act of 2006, most small tax-exempt organizations whose gross receipts are normally \$50,000 or less must file Form 990-N, Electronic Notice (e-Postcard) for Tax-Exempt Organizations not Required To File Form 990 or 990-EZ. Before this law was enacted, these small organizations were not required to file annually with the IRS. The first filings were due in 2008 for tax years ending on or after December 31, 2007.

1. When is the *e-Postcard* due? How often do I need to file?

The *e-Postcard* is due every year by the 15th day of the 5th month after the close of your tax year (usually the same as your accounting period). For example, if your tax year ended on December 31, the *e-Postcard* is due May 15 of the following year. If the due date falls on a Saturday, Sunday or legal holiday, the due date is the next business day.

If you do not file your *e-Postcard* on time, the IRS will send you a reminder notice but you will not be assessed a penalty for late filing the *e-Postcard*. However, an organization that fails to file required *e-Postcards* (or infor-mation returns – Forms 990 or 990-EZ) for three consecutive years will <u>automatically lose its tax-exempt status</u>. The revocation of the organization's tax-exempt status will not take place until the filing due date of the third year.

Can an organization file an e-Postcard for a prior year? You can file an e-Postcard for a prior year through one of our approved e-file service providers. However, you cannot file an e-Postcard for a prior year through the link on our site to the filing system. For example, if the organization's tax year ended on December 31, 2009, and you attempt to file your 2009 e-Postcard after the close of your 2010 tax year (December 31, 2010), the filing system only will allow you to file for 2010. While there is no penalty for late filing an e-Postcard, your taxexempt status will be automatically revoked if you don't file for three consecutive years. Note: The requirement to file Form 990-N is an annual requirement.

Some are public events where other agencies will see the activity and the Lions in service and we have direct contact with families. Then the excitement gets ramped up when we begin in-school screenings. As has been the path the last several years, the very rural Red Rocks schools is first on the calendar.

Clearly the calendar will be very busy through the middle of November and maybe even into December.

Know that the Green Valley La Canoa Lions organize additional screenings in the greater Green Valley area. South Tucson Lions are also working with the Sunnyside USD. Safford Lions have a very active screening program.

The early public events are a really good way to refresh or hone your screening skills. Please sign up early and often.


