4th Quarter Cabinet Meeting, April 25, 2019

The Lions of District 49A and MD49 have had another banner year of visionscreening. Per capita we screen more children than any other Lions group in the world. Through April 20, 2019, a total of 19,294 children were screened with 2,651 referrals and 547 that we were unable to screen for various reasons, inability or unwillingness of the child to focus on the camera, shape of the eye. A child with Amblyopia cannot be screened because both eyes don't focus at the same time. The screener can see this when they look at the screenshot of the child on the camera.

Last year we were given life use of an Optical Scanner by the Alaska Health Fair group. This device is used to screen our adult population. We have used it at health fairs and at the Alaska State Fair. Please let me know if your group would be interested in using one of these scanners at your events.

With the valuable help and support from our Aurora Borealis Lions Eyeglass Recycling Center the Lions have distributed over 500 pair of reading glasses to those in need. That count will more than double when our Lions go to Guatemala this year.

The reorganized Anchorage Area Joint Sight Committee has set up a new webpage dedicated to our Lions work with vision in and around Anchorage. They hope to be able to expand the area covered later. The website will have the forms needed to request exams and glasses, a list of drop off locations for donated glasses, visionscreening schedules and forms and articles of interest. Check it out at www.anchoragelionsvision.org

We have received the district's annual supply of VSP certificates. Because they are issued on a first come first served basis we were not able to get our full allotment of 250. We received only 100. See me after the meeting to get your committee's limited supply.

Our Lions have worked on projects designed to prevent blindness, restore eyesight and improve eye health and eye care for hundreds of millions of people around the world as we continue to follow our motto of "We Serve".

During the year visits in person, teleconference or electronic communications were completed with all clubs Telephone contacts were ongoing with any club that needed assistance. Information was provided via email. Each club received a poster and plastic holder to advertise Lions. This occurred in 49A. Due to coved I did not get to visit 49B. At the convention I will have the posters and frames to distribute to 49B.

In February a need arose with many clubs on officer training. I have been able to visit in person 11 clubs and train 78 Lions. I have done an additional 12 Lions from 5 clubs over the phone or met individually with them. More visits are planned prior to June 30. At the trainings packets were provided for the offices of President, Vice-President, Secretary and Treasurer. The packet included the ebooks on each specific office. 4th QUARTER SIGHT REPORT MAY, 2021

This year our sight programs changed, probably forever. We were not invited into our schools to do onsite Visionscreening. We were not invited to do Stand Down and Homeless Connect. KidsDay and the Baby Expo were cancelled. Our Joint Sight Committees found fewer eye doctors to take care of our friends in need. To follow our "We Serve" motto we had to adapt. To that end, in Anchorage, we partnered with the DHHS, the Muni and the ASD to do Visionscreening clinics in school parking lots using our trailer. That did not happen until the last week of January, 2021.

We were not allowed to go inside the schools in Anchorage until the middle February and then only with the principal's permission. Schools outside of Anchorage have not yet allowed us to start screening. We have preformed 7,336 screening through yesterday with a 30% rate. Prior years' referral rates were around 16%.

Our Aurora Borealis Lions Eyeglass Recycling Center at the North Pole continues to collect, clean, sort and distribute readers. Please consider volunteering a Saturday to help them continue their good work.

Our supply of VSP certificates has been replaced. If any club needs certificates please let me know. I currently have 20 certificates to give out.

Each of our clubs across Alaska and Canada have helped in our crusade against preventable blindness. We all have our stories to tell of the children we have helped. We would like to hear them. Please send them to me so we can share.
