This Membership Minute focuses on services provided by International Headquarters.

The Association's Headquarters supplies essential service to the support, growth, and development of Lions and their Lions Clubs. Lions take advantage of these various activities and materials in their quest to serve.

International Headquarters is located in Oak Brook, Illinois, near the home of founder Melvin Jones, who served as acting secretary for 44 years, until his death in 1961. Responsibilities at the International Headquarters are varied and challenging.

There they keep ALL records of ALL Lions and ALL Lions activities.

They develop, print, and distribute a wide variety of brochures and manuals. This includes the Official International Directory of all 44,000 Lions Clubs – covering the meeting time and place, the Club President with address; District Governors, International Officers and other information.

Headquarters organizes and carries out the International Convention each summer and the USA/Canada Forum each fall.

An annual International Board of Directors' meeting is required by Constitution to be held at Headquarters. For over a week, there are major Board activities along with daily work.

Also, individual Lions and Lion groups frequently visit Headquarters to tour, get help, or offer advice. Since you and your club are the basis of service in Lionism, you are expected and welcomed.

Another responsibility is to assist with International Service Activities Projects, such as Lions Clubs International Foundation and SightFirst.

A particularly important part of the services International Headquarters provides is communication with members. The new and improved Website provides much and varied information. And, the Lion Magazine, established in 1917, is published in several languages and delivered to all 1.4 million members.

Needless to say, the International Headquarters sound like a very active place. In the next Membership Minute we will take a closer look at each of these services mentioned today.


The Foundation provides support in four areas of service:


> Preserving Sight Serving Youth Disaster Relief Humanitarian Efforts
