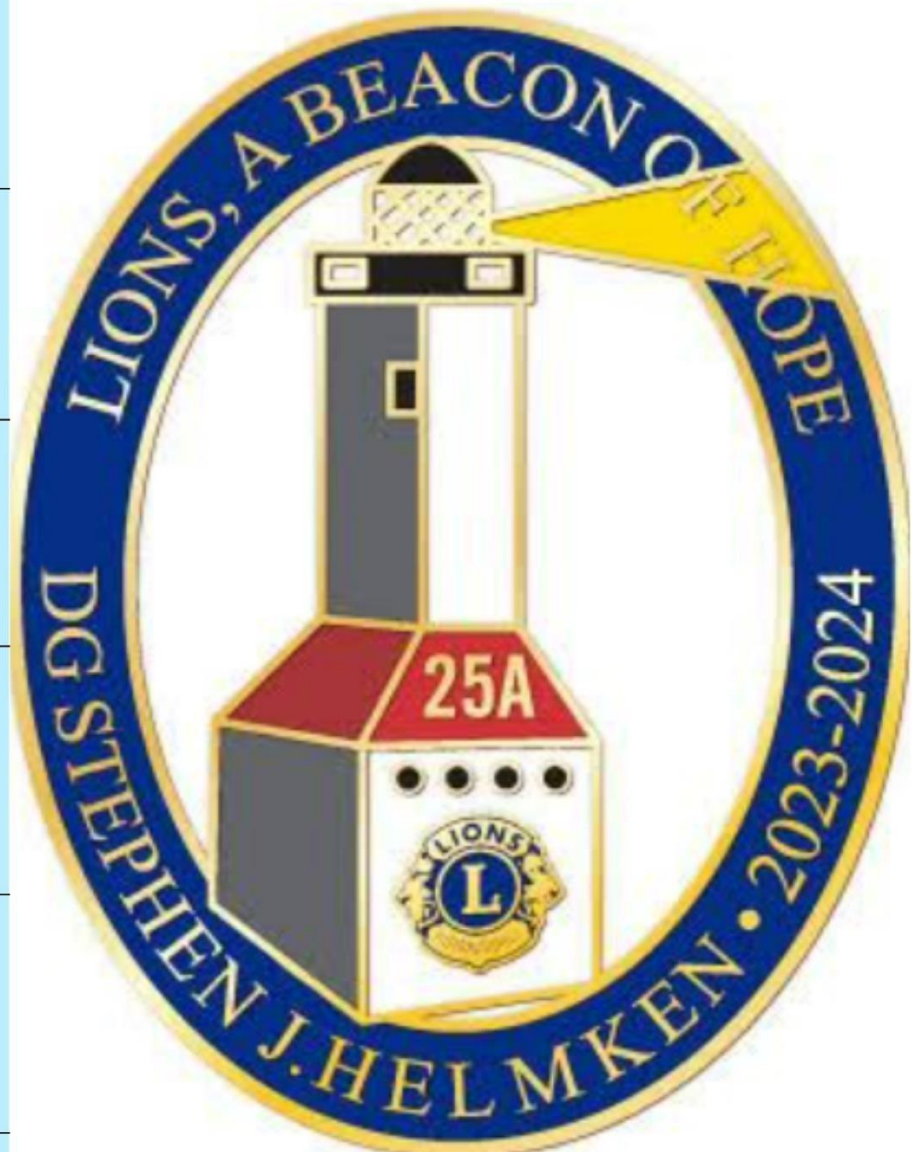

Lions Portal

Once you have your username and password, you will be directed to the Portal.

My Membership will take you to the information about you – membership number, club name, birthdate, etc. You should be able to maintain your own personal data – i.e. change your address when you move.

My Club will show you information about your club. If you are a club officer (i.e. secretary, treasurer, president, etc) you will be allowed to make changes – just as you did in MyLCI in the past. If you are not an officer, you can just browse the information.

My CA will show you information about clubs in your district (25A) or state (MD25) or constitutional area (CA 1). Except for some district officers, most Lions will only be able to view the data here.

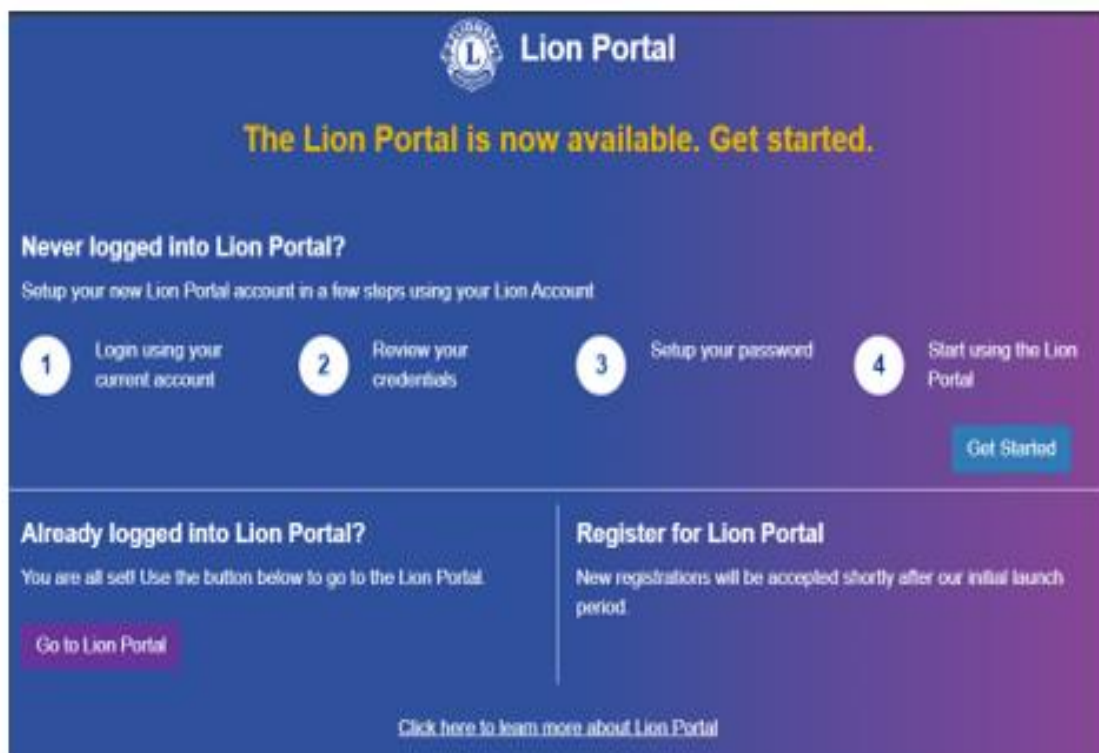
My Association is for the generation of reports – a valuable tool for Lion leaders at any level.
