The solution is dilution

"We don't do it that way!" or "we have never done that before!" are all expressions that unfortunately are heard at too many Lions Club meetings. We get comfortable in the way things are done. We like routine but with routine comes being in a rut and inflexibility. New members, who may be interested in joining the club are put off by "the old guard" and all of the things that have "always been done". They come to a meeting expecting to talk about some service project but only find discussions of a pancake breakfast or tenderloin fry fundraiser. This is not what interested them in Lions. Fundraisers are important for the community service they support but they are not an act of service to the community.

So, how does a club change this or rather how do interested club members change this? The simple solution is "dilution" – find more new members to come into the club so that the old members are outnumbered by the new members. The new members then have enough resources to accomplish new acts of service – going to a daycare, doing a School Sight screening or other things that members don't want or are not interested in doing. Initially it may require a group of members working with a zone chair or another club to help with some service project. It may be a group of clubs coming together to tackle a bigger project. The important outcome is that something happens in the community that helps the community.

We need to stop thinking in terms of "what we have always done" and ask "why are we doing that – is there a better way?". Growth occurs when we are no longer satisfied with the "same old thing" but are looking for new ways to serve those around us. People join the Lions club to make an impact on their local communities – not to serve food or sell items. The Lions motto is "We Serve" – not "We sell things". All clubs can find some sort of service project for their community. It doesn't have to be large – it just needs to help someone. Don't fall into the trap of "but it was only...." – If you are serving someone in your community – that act of service is important to them. Build upon it, expand it – serve your community and then ask those around you to help you continue and expand the work. You will be amazed at the interest you will find.

From the Desk of CS PDG Ann Haffner November Deadline Reminders!

FORM 990-N All Lions Clubs who have annual gross receipts of \$50,000 or less and do not have to file Form 990 or Form 990-EZ <u>must file</u> 990-N (e-Postcard) **by November 15** each year. You'll need your club's EIN (employer identification number.)

There is no penalty assessment for late filing, but an organization that fails to file e-Postcards (or Form 990 or 990-EZ) for three consecutive years will <u>automatically lose its tax exempt status</u>. The revocation will not take place until the filing due date of the third year. Do not let this happen as it can be extremely complicated and costly to regain your club's tax exempt status. Complete information can be found at <u>www.irs.gov/eo</u>.

If your club has annual gross receipts of \$50,000 or more you'll need to file Form 990 or Form 990-EZ <u>by</u> <u>November 15</u>. The same penalties will be in force if you do not file.

FORM <u>NP-20</u> If your club has an Indiana Sales Tax Exempt Certificate you must file Form NP-20 each year with the Indiana Department of Revenue <u>by November 15</u> in order to keep your sales tax exemption up to date. The form can be found at <u>www.in.gov/dor/</u>. Click on "Forms," then "Business," then "Nonprofit," then "NP-20." If your club does not have an Indiana Sales Tax Exempt Certificate, the application form "NP-20A" is available on the same page.

<u>BUSINESS</u> <u>ENTITY</u> <u>REPORT</u> Each year during the anniversary month of the incorporation of your club the Business Entity Report must be filed with the Indiana Secretary of State. You may, or may not, receive a reminder in the mail. The Form can be downloaded from <u>www.sos.in.gov</u> and mailed with \$10.00 or can be filed online using a club or personal credit card for \$7.14. Click on "Business Services Division," then "Division Forms," then "Business Forms," and finally "Business Entity Reports."

FAMILY UNIT CERTIFICATION: Several clubs have not filed Family Unit Certification with LCI and are being charged full international dues (\$21.50 semi-annually) for the second, third, etc. family members living at the same address and belonging to the same club. When submitted correctly, your club will be charged only \$10.75 semi-annually for those members. A few clubs have not reported all they are eligible to report. That may be because husbands and wives (or other Lions living in the same household) are not all listed at LCI with the same address. If a family member's business address, rather than their home address, is on record at LCI, that would have to be changed in order to enroll the members in Family Certification. If you need to file or correct your club's Family Certification on the MyLCI website it must be submitted by November 30 in order for it to take effect for the LCI January 1 dues billing.

LION CHARLIE'S CORNER HOW TO BE A SUPER LION AND ENJOY IT

As the years go by changes occur in our lives, our families, our towns and in almost everything we do. We have to periodically do different things or change the way we do things to keep having the success we have had in the past.

Many of our Lions Clubs have made few changes as the years go by. As the club membership changes because of the addition of new members and the loss of experienced members it is vital that periodic evaluations of everything your Lions Club does occurs.

In some clubs this evaluation occurs because individual Lions assume this responsibility. Other clubs make a yearly evaluation of the club one of the first responsibilities of the newly elected board of directors. But most clubs simply drift from one year to the next with little change. And when this happens a Lions Club is almost certain to decline in service and will eventually disappear.

Becoming an Effective Lion

At the next meeting of your Lions Club take a few minutes to look around the room at each one of your members. As you do so mentally place them in one of the categories listed below.

- 1. Active Leader—welcomes new ideas, works well with others, helps make everything go smoothly, asks people to join your club
- 2. Regular Member—attends meetings, works projects, wears pin, dependable
- 3. Borderline Member-attends irregularly, works some projects, never wears pin, never volunteers
- 4. Antagonistic Member-resists change, outspoken, can be openly critical

Each one of us can easily develop skills, projects, and ideas which greatly strengthen our Lions Club and protect it from decline. As we grow in our Lions work we will make it possible for others to succeed beyond their expectations.

As you examine the following ideas think about the opportunities you have to use them or share them with others. Your value to your Lions Club increases every time you use one of these ideas to strengthen your work in Lionism.

- Membership Program
- Eyeglasses Collection Box
- Needy Student Eyeglasses or Hearing Aids
- Blood Donor Program (with school)
- Recycle LION magazine (barbershops, doctors' & dentist's offices, lawyer's offices, styling salons, car service waiting rooms, hospital waiting rooms, etc.)
- Become a District Officer
- Develop a New Club Project or Fundraiser

LCIF Helps You Help Millions Around the World


