



How much do you know about your LCIF? Do you know what LCIF stands for? What does LCIF do? How does LCIF get its money? Does District 25- get any of that money? Where does District 25-E stand at giving money to LCIF?

I've just listed several questions about LCIF. Let's see if we can answer them

LCIF stand for Lions Clubs International Foundation. LCIF has provided grants of nearly one billion dollars to support local and global projects. Foundation grant support will make it possible for Lions to immunize millions of children against measles and rubella, prepare for and respond to hundreds of devastating natural disasters, serve more than 240,000 special Olympics athletes and their families, improve education, health care, and other social services in hundreds of local communities, teach critical life skills to 200,000 additional students annually through Lion's Quest and identify and support thousands of people impacted by diabetes. How does LCIF get its money?

Every Lions Club and individual member is asked to donate at least 20 percent more of their average annual charitable giving of Lions Clubs International Foundation, the official charity of Lions Clubs International. I am asking the Clubs of District 25-E to give to LCIF this year. Remember if we don't give there may not be any money when we need it. The money comes from us, not our dues. It comes from us giving donations to LCIF.

Does 25- E get any of that money? Just ask Fayetteville and other Clubs that have had a natural disaster. When Fayetteville got hit by a tornado the District got grant money to help. The Dstrict got grant money to help flood victims. Remember if we don't give, what will happen when the next disaster hits home?

Where does District 25-E stand right now in giving to LCIF? We are last in the state on the giving list. I know we can do better. District 25-E doesn't want to be last. Lets move up in giving this year. Let's be a part of something wonderful.

Our donations to LCIF have helped vaccinate more than 200

million children against measles and rubella. Twenty million is needed to provide disaster grants to help Lions Districts and their disaster relief partners respond to cases of wide spread devastation. Eighteen million is needed to assess and significantly update all three Lions Quest curricula and implement the program in 20 new countries and 10 existing markets by 2018. With your support we can do this.

Fifty-three million is needed to support matching grants for Lions local humanitarian initiatives. Seven million is needed to support grants of Lions' community based diabetes education programs.

From 1990-2009 District 25-E1 was given \$155,932 in grants.

From 1990-2008 District 25-E2 was given \$66,000 in grants



Bremen joins Madison Twp. for biannual pork chop sales

The Madison Township Lions Club held its biannual pork chop sale on Sept. 17, with sales at the Wyatt Fire Station and at Woodie's Supermarket in Bremen.
