## Motion #2 - Requested policy manual change.

Every year District A3 conducts District Officer training and Cabinet Zone chair training. The expenses for these events are covered in each year's budget, except for compensation to instructors who are asked to conduct the training. In the case of zone chairs they are eligible for rules of audit expenses in their year of duty but not when elected. In past this has been paid by the district as a separate budget line. I propose that we amend the policy manual to include a provision to allow the instructors to claim either rules of audit milage or \$25 honorarium whichever is higher. The amended policy would be as follows;

### Policy 2.0 District Financial Policy

New item 16. Lions acting as instructors for District Officer, and Cabinet training will be provided Rules of Audit milage or \$25 honorarium, whichever is greater for providing requested District training.

## **District Directory**

Every year District A3 creates as District Directory (White Book) at a large cost. After seeking the opinion of the PDG group it was found that the overall majority opinion was to have the directory on-line only, with a couple of Lions desiring either a hybrid of printed and on-line or just printed.

On Sep 3 the DG sent an e-mail poll (vote) to all cabinet members to determine the way forward copies. and conducting an e-mail poll of cabinet members. 10 members selected on-line only, 1 selected print version and 4 abstained or did not reply to the e-mail. Based on this result the directory will be on-line only this year.

This will require a change to the Job Description Manual section on District A3 Directory

Under Objective – change to read "To produce the District A3 information Directory (White book) annually for publishing on the District website and distribution electronically to required recipients."

Under Duties and responsibilities –

Edit bullet 2 to read "Publish the District Directory and distribute prior to the first Cabinet meeting in the Lion's year"

Edit Bullet 4 to remove line "Advertising may be included in the Directory at the discretion of the District Governor and Cabinet"

Edit Bullet 5 to remove "but are not listed in the official publications list."

Edit Bullet 6 to remove "such corrections will be sent to all Lions holding copies of the Directory."
