MESSAGE FROM THE DISTRICT GOVERNOR

Even as our three counties will have transitioned to “yellow” by the time you read this, our meetings and events are still limited to 25 people. Most of our fundraisers and many of our service projects simply can’t be held.

Yet my disappointment is overcome by my joy. It has been a joy to see all that our clubs and Lions around the world do to serve people in need. It has been a joy to work with you. You have supported our District projects generously, even as finances became tighter. Every club is within the current range on state and international dues, and most paid their district dues promptly in spite of a very late invoice. Our service reporting is high and growing.

If you still want to support our projects, our treasurer needs to receive those funds as soon as possible. We understand that you will need to be creative as you look to make up for the resources that were lost because of the pandemic.

The reality is that we Lions will need to step up to help a lot of our neighbors, as many are already doing.

Some jobs will be permanently gone, small businesses will be unable to re-open, and health needs aggravated by the virus will not go away. What is your club doing to identify these needs and to plan for ways to alleviate them?

Have you investigated the ways to meet that technology now makes possible. Our State Council met via ZOOM, with nearly 80 participants. Yes, my computer decided to throw a fit, but I got in eventually. I think only one of us couldn’t log in. Which isn’t bad for people who in most cases remember party lines and rotary dials.

Maybe some of your meetings going forward (especially short ones) can be conducted using these technologies. Perhaps you might want to have fewer dinner meetings, to reduce the expense of being a Lion. Maybe we can all investigate how we can be more effective and efficient in serving using 21st century technology.

Most of all, though, I have confidence in how all of you will find ways to adapt to whatever this “new normal” we hear about might be, because you care about your neighbors and your community. And you have elected great leaders in Lions Tom, Dan, and Ortrun. Please give them the support that you gave me. And know that I will continue to do my best to make sure one thing holds true:

“Where there is a need, there is a Lion.”

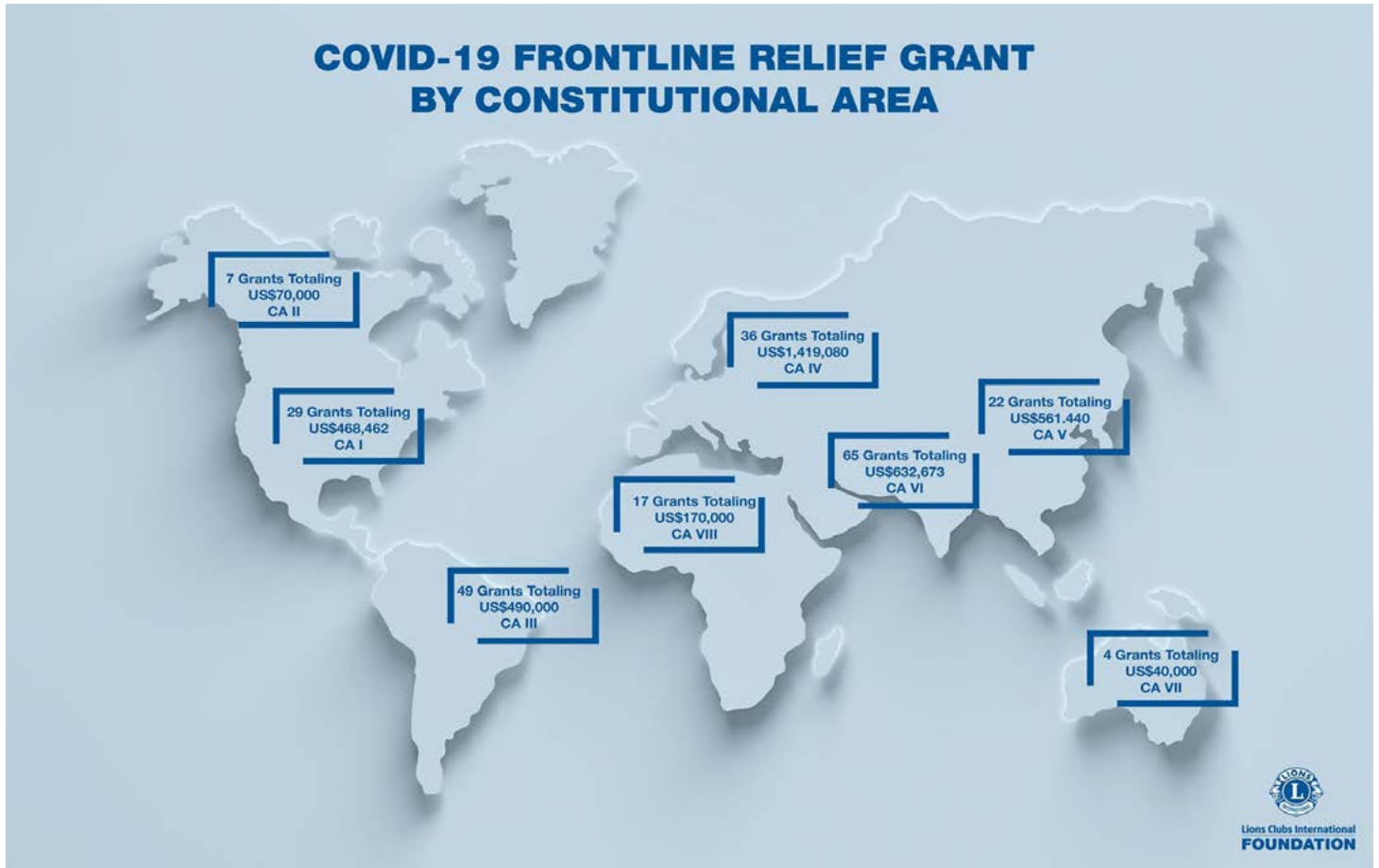

COVID-19 FRONTLINE RELIEF GRANT UPDATE:

Thanks to your generosity, LCIF has now been able to award 229 grants to Lions Clubs totaling US \$3,851,655.



LCI LEGAL'S TAX REMINDER

“Please remember that all Lions clubs, districts and multiple districts that have annual gross receipts less than US\$50,000 and do not have to file Forms 990 or 990-EZ must file the e-Postcard (also known as 990-N). If your Lions club, district or multiple district has a foundation, which is a separate legal entity, the appropriate form will need to be filed as well.”

HELP FIGHT IDENTITY FRAUD

In advice from LCI's Legal Division, a general rule to follow is: Information such as individual Lions' names, mailing and email addresses and telephone numbers should not be posted on or made accessible on websites.

LIQUOR NOT PERMITTED IN BASKET RAFFLES

Please be aware: A popular staple in basket raffles is a “no-no.”

After researching the matter with the Executive Director of the PA House of Representatives’ Liquor Committee and the PA Liquor Control Board, MD-14 legal counsel Lion Ashley Grimm reported that “liquor is not permitted to be in a basket for purposes of a raffle. This also includes silent auctions.

“This equates to selling liquor without a license,” Lion Grimm said. “A wine and spirits gift card is permitted to be included in a raffle basket, though.”

Lion Grimm’s research supported the opinion expressed by Lawrence County Treasurer Richard Rapone in a recent New Castle News story that had prompted MD-14 State Council Chair Bill Morgan to contact Lion Grimm. As part of the News story, Capt. Jamie Jones of the LCB Enforcement Bureau said including any type of alcoholic beverage – be it a six pack of beer, a bottle of wine, a bottle of whiskey or the like – is a violation of the Pennsylvania Liquor Code, Title 47, and is an unclassified misdemeanor offense. The fine upon conviction is \$500, levied to the organization sponsoring the fundraiser and not the donor of the basket.

In the News story, Rapone pointed out, under the state’s small games of chance law, it is illegal to host basket raffles at fundraising dinners used to benefit someone who is sick.

CHECK PLEASE! EIN NUMBERS

The State Office reminds district and club treasurers that each club and district should have its own Employee Identification Number (EIN) and file a yearly report with the Internal Revenue Service (IRS).

Clubs should not use the EIN assigned to the PA State Council of Lions Clubs and/or Lions Clubs International.

ELECTION NEWS

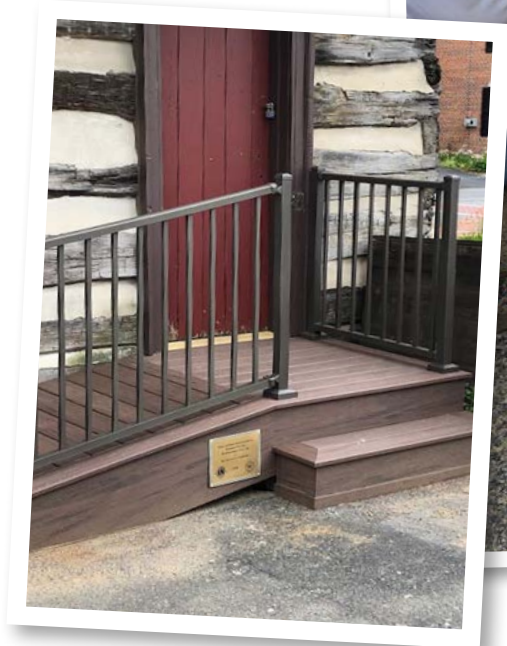
All clubs need to complete elections for Lions Year 2020-2021 and update their officers on the MyLCI website by May 15th. Some guidance from LCI Legal on conduct of club elections follows:

All Lions clubs are permitted to conduct meetings via alternative meeting format. Therefore, they can conduct elections via phone, email, or any other method that will permit the Lions club to move forward.

Practically speaking, as each Lions club is an independent legal entity, it can conduct elections (or choose not to conduct elections) at the discretion of the club. Provided the decision is supported by the membership and no complaint is filed, the actions of the club will be accepted in good faith.

Ballot Question 1

THE FOLLOWING RESOLUTION CONCERNS AMENDING THE INTERNATIONAL ASSOCIATION OF LIONS CLUBS MULTIPLE DISTRICT-14 (PENNSYLVANIA) CONSTITUTION. TO BE ADOPTED, THIS AMENDMENT TO THE CONSTITUTION REQUIRES AN AFFIRMATIVE VOTE OF TWO-THIRDS (2/3) OF THE CERTIFIED DELEGATES CASTING A VOTE.

A RESOLUTION TO PROVIDE ADDITIONAL LANGUAGE TO ARTICLE VII, SECTION 4, COUNCIL CHAIRPERSON.

THE RESOLUTION ADDS LANGUAGE TO CLARIFY : 1) THE TERM OF OFFICE FOR THE COUNCIL CHAIRPERSON; 2) THE SELECTION PROCESS FOR APPOINTING A REPLACEMENT IN THE EVENT OF A VACANCY IN THE COUNCIL CHAIRPERSON POSITION; AND 3) THE COUNCIL CHAIRPERSON ROTATION.

BE IT RESOLVED, that effective July 1, 2021, Article VII, Section 4, will read as follows:

“Section 4: COUNCIL CHAIRPERSON. The Chairperson of the State Council shall be the Immediate Past District Governor who had served in the capacity of Vice-Chairperson during the preceding year, who for the year 2020-2021 shall be from Sub-District P. The Council Chairperson shall serve for a one-year term only and cannot serve in that capacity again.

In the event, either before or after becoming the Chairperson, if unable or refuses to serve, or having accepted, resigns or dies, then the District Governor of that sub-district shall appoint a Past-District Governor who is resident in and a member in good standing of a Lions Club in that sub-district to serve out the term of office. If no Past District Governor from the sub-district is willing to serve, then the sitting Council of Governors will appoint a Past District Governor from the two preceding State Councils who is a resident in and member in good standing of a Lions Club in Pennsylvania to serve the remaining term of office. The normal Council Chairperson rotation will resume when the replacement Council Chairperson’s term of office is completed.

THE FOLLOWING RESOLUTION CONCERNS AMENDING THE INTERNATIONAL ASSOCIATION OF LIONS CLUBS MULTIPLE DISTRICT-14 (PENNSYLVANIA) BY-LAWS. TO BE ADOPTED, THIS AMENDMENT TO THE BY-LAWS REQUIRES AN AFFIRMATIVE VOTE OF THE MAJORITY OF THE CERTIFIED DELEGATES CASTING A VOTE.

A RESOLUTION TO PROVIDE CHANGES TO ARTICLE VI, SECTION 2, DISTRIBUTION OF FUNDS.

THE RESOLUTION MODIFIES THE DISTRIBUTION OF THE CURRENT \$16 PER-CAPITA DUES AS FOLLOWS, STARTING JULY 1 2021:

- ELIMINATES THE “PROMOTION FUND” OF \$0.35
- INCREASES THE “STATE COUNCIL ADMINISTRATIVE FUND” FROM \$8.50 TO \$9.60
- INCREASES THE “SUB-DISTRICT ADMINISTRATIVE FUND” FROM \$2.50 TO \$3.00
- REPLACES THE “PENNSYLVANIA NEWS PUBLICATION FUND” WITH THE “COMMUNICATION/WEB/PRIDE FUND” AND REDUCES THE ALLOCATION FROM \$1.50 TO \$0.25

THE RESOLUTION **DOES NOT** INCREASE OR DECREASE THE CURRENT OVERALL DUES

BE IT RESOLVED, that effective July 1, 2021, Article VI, Section 2, will read as follows:

Section 2. DISTRIBUTION OF FUNDS. The funds so collected shall be used, distributed, and credited as follows:

- a. State Convention Administrative fund - \$0.45
- b. International Convention Fund - \$0.85
- c. District Governors International Convention Expense Fund - \$0.35
- d. State Council Administrative Fund - \$9.60
- e. Sub-Districts Administrative Fund - \$3.00
- f. Communication/Web/PRIDE Fund - \$0.25
- g. All-State Band - \$1.50
