Message from the District Governor

One characteristic our thriving clubs share is outstanding leadership. These clubs have members who

are willing to take charge and unselfishly give their time and energy to the activities of their club.

While some aspects of leadership are innate, leadership skills can be learned and enhanced through training. One benefit of being a Lions club member is access to leadership training and the opportunity to develop one's leadership skills. Development of leaders and leadership skills at the club level is critical to the success of our organization. The leaders of our international organization all started as leaders at the club level. One does not get to be a District Governor, International Director, or International President without first serving as a Club President. Therefore, we need each of our clubs to continually recruit members who show leadership potential, support our club members who show leadership skills by sending them to training seminars, and encourage our club leaders to advance their service above and beyond the club level.

As Lions, our motto is, "We Serve." While that motto is generally seen as serving our communities, it also applies to serving our organization. Just as clubs need strong leadership to thrive, our District needs strong leaders to help support our clubs and allow our district to thrive. We need people to step into the role of Zone Chair and accept the responsibility to serve as Vice District Governor, and eventually District Governor. Yes, this is an extra commitment of time, energy and resources, but there are also many intrinsic rewards.

Please encourage the outstanding leaders in your club to further their service by volunteering to engage in District activities and take on District leadership positions. I am confident those of you who accept this challenge will not be disappointed in your decision to expand the scope your service, and that you will find great satisfaction in sharing your leadership talents with Lions on a broader level.

LCI Legal's annual tax reminder

Please remember that all Lions Clubs that have annual gross receipts less than \$50,000 and do not have to file Form 990 or 990-EZ **must file the e-Postcard** (also known as 990-N). If your Lions Club has a foundation which is a separate legal entity, the appropriate form will need to be filed as well.

LCI Legal advises: Don't Go "Phishing"

Lions Clubs International is aware of solicitations being received by some of our clubs that refer to money being left to, won by or owed to a Lion or a club and/or asking for personal information or account information of the club. Please keep in mind when reviewing these types of emails/letters, if they seem too good to be true, they probably are. LCI has seen many of these types of correspondences and they are a scam.

Please disregard and do not respond to these types of fraudulent solicitations. Further, any club that receives these types of solicitation may wish to contact the local authorities to request an investigation and further action as appropriate under local law.

Clubs **should not** use the EIN assigned to the PA State Council of Lions Clubs and/or Lions Clubs International.

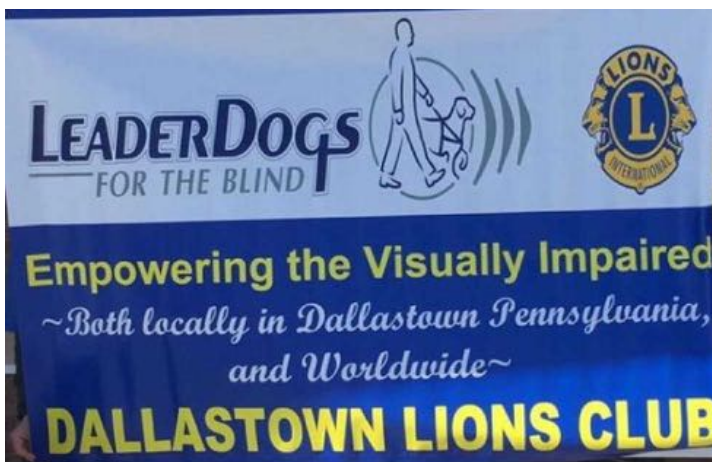

Serving Together: The Green Family of East Berlin Lions

This month we travel to Adams County to highlight the hard work of Gregory and Linda Green of the East Berlin Lion Club. Lion Greg is serving in his sixth year as President while Lion Linda is in her third year as Secretary.

Linda is originally from the Mechanicsburg area, and like other Lions we have profiled in the past, she spent her career in elementary education, primarily as a second and third grade teacher. Prior to her retirement though, she accepted the challenge of teaching “ESL” students, which stands for “English as a Second Language”. Greg is a retired programmer for IBM. They have been married for 44 years.

Greg initially served his community as a member of the East Berlin Borough Council. While there, he met Charles Eisenhart, who convinced him to join the Lions Club. After being a member for less than a year, Greg told Linda that there were also women members in the Lion’s Club and Linda joined also. Linda had known about the local Lions Club because she saw the signs at the end of town, but she was surprised that she didn’t personally know any of the members even though she had lived

in the area for over 30 years.

It did not take long for Greg and Linda to step up and serve as officers in their club. Greg initially served as 1st Vice-President, and, as noted above, has been President for the past six years. He enjoys the social and fundraising aspects of Lionism, particularly the raffles and Christmas Tree sales which raise money for community projects. One example is the re-building of the horseshoe pit at the borough park.

Charles Eisenhart, the Lion who recruited Greg, had been the Secretary of the club for over 40 years. When he needed help, Linda stepped up to assist him, and ultimately succeeded him as Secretary. She has been involved with the vision screening program from the beginning. As noted above, her teaching career brought her into contact with elementary school age children who

had never had any preventative medical care, including eyesight testing. She is very pleased with the program and hopeful for its expansion, because she strongly believes that if we can only help one child with eyesight issues we have made a great difference.

Linda believes that direct contact with the community through organizational partnerships is a great tool for Lions Club recruitment and the community. She has recruited a woman business owner who joined with her son. She has been able to hold fundraising events at local businesses where older club members who “know everyone” can take the lead in selling raffle tickets and other fundraising items. She also promotes assisting other clubs with their fundraisers and working with the InterAct program at Bermudian Springs High School. All these activities promote Lionism and give the East Berlin Lions great publicity to engage new members.

Greg and Linda Green are examples of a Lion family always looking for potential new members and ways to keep existing members active and involved. Engage with someone in the community who you have something in common with and you may just find a new member who, like Lion Greg Green, may bring their spouse and other community members into Lionism to educate others in what wonderful things we do.

The New Freedom Lioness Club is a non-profit community service organization. Please help us make this Christmas Bazaar a successful event by following these rules:

This event will be open to the public from 8:00 AM until 3:00 PM. Vendors will be allowed in at approximately 6:00 AM and all vendors should plan on being packed up and out of the Community Center by 4:00 PM. The New Freedom Lioness Club will be selling baked goods, breakfast sandwiches, soup, sandwiches and beverages.

1. Spaces are approximately 10' x 10' for \$40.00, in advance. Tables will be available for \$5.00 each. **At this time, there is no Wi-Fi available at the Community Center.**
2. Each vendor is expected to remain open and available for purchases the duration of the event.
3. Each vendor is responsible for setting up the tables and chairs in their space. The tables are the property of the New Freedom Community Center and care should be taken not to damage them.
4. Each vendor is responsible for returning all tables and chairs to the storage area in the back of the Community Center.

Pennsylvania Counsellors Distinguished Service Award

The Pennsylvania Counsellors have established an award for presentation to deserving Lions throughout Pennsylvania - The **Pennsylvania Counsellors Distinguished Service Award**.

Each District within Multiple District 14 may present **two (2)** *Pennsylvania Counsellors Distinguished Service Awards* annually. The award is limited to **one (1)** per club per year and only one (1) award per District may be presented to a Past District Governor. Persons who have received a prior ***Pennsylvania Counsellors Distinguished Service Award, Lions International Leadership Award, Lions International Presidents Award, or the Lions International Ambassador of Good Will Award*** **are not** eligible for this award.

The following are the criteria to earn this award:

- A. Have served at least ten (10) years as a Lion,
- B. Have earned at least five (5) years of perfect attendance,
- C. Shall have served as either President or Secretary of their Club, or have displayed other exemplary service.
- D. Must be a Lion in good standing in a Lions Club in good standing in their District within Multiple District 14.

Applications for the *Pennsylvania Counsellors Distinguished Service Award* shall be submitted by the Lions Club President to the Chair of the District 14-C Past District Governors Honorary Committee (**PDG George Hilsinger, 50 Foreman Mill Road, Shippensburg, PA 17257**) no later than December 1st. The Past District Governors Honorary Committee will review all of the applications received and recommend two (2) for the awards. The Chair shall endorse the recommended applications and forward them to the District Governor for his/her endorsement. The applications must be received by the Secretary of the Pennsylvania Counsellors at least two (2) weeks prior to the February State Council Meeting.

The awards will be presented at a District Function by the Chair of the District 14-C Past District Governors Honorary Committee.
