

Multiple District 5 – Business Session Minutes Saturday May 31, 2025 – 2:15 PM Whitecap, Saskatchewan CC LeeAnn Haisch – Presiding Officer

Call to Order @ 2:37 PM by CC LeeAnn Haisch

Acceptance of Minutes from the 2024 MD5 Convention in Minot ND - Lion Lois Reierson- Motion by DG Heather and seconded by DG Lynn to accept the minutes with the correction on upcoming conventions in the Business Meeting 2 minutes. It should read 2025 convention is SKN and 2028 would be SKS. Motion carried with correction.

Acceptance of Financial Report - Treasurer PCC John Emmett

MD5 has a considerable balance as of May 21, 2025. There are no expenses from the 2025 summit or MD5 convention. Checking account has \$111,195.40 balance and money market has \$163,998.66 balance for total of \$275,193.86 with a -\$.20 in savings. MD5 is under budget which is partially due to no council meeting in March. There is over \$21,000 in a youth camp fund. \$3,000 per year is placed in a campaign reserve fund to support Lions in MD5 running for Intl Director. The GMT, GST, GLT, GET spent less than ½ of their budgets. The incoming council was challenged to 1) increase GAT team budgets to \$10,000 2) spend money wisely in coordination with the districts 3) consider what is needed with the \$10,000 budget. ID John Lawrence shared that training is being moved to the Multiple Districts. He encouraged MD5 to hold an RLLI. RLLI and ELLI build leaders and help with leadership, membership, service and extension. Treasurer John encouraged Lions to let him know their ideas before finance meetings. Motion by DG Ray and seconded by DG Dennis to accept the Finance Report as presented. Motion carried.

Reports from the MD5 Standing, Elected, and Appointed Committee Chairs
Global Leadership Team Chair - PCC Tim Haight will be holding monthly meetings with district GLTs. Training held in districts will be available to all districts. Twelve to sixteen Zoom trainings were held this year as short one-hour sessions for VDG training along with some in person training. The Estevan training went well. He will be planning an RLLI for the upcoming year. It is important to get a date set soon and get the word out.

Global Membership Team Chair - PDG Mark Koller – Extension and membership go hand in hand. He recognized the district GMTs that are doing a great job.

Global Extension Team Chair – PDG Lynn Grabow – He suggested more needs to be shared at conventions about service. 5SKS, 5NE and 5NW have chartered new clubs and there are more coming. Guiding Lions are needed to have successful new clubs.

Global Service Team Chair - PCC Jeanette Bean – No report. The 2025/2026 GST will be PDG Krisha Ashby from 5SE.

Lions Clubs International Foundation Chairs - PDG Dave Czywczyski and PDG Rob Hill – US has two districts with over 100% donation to LCIF. Stats so far in the US districts are 5NE is at 129%, 5NW is at 151%, 5SE is at 73%, 5SW is at 93% for total contributions of \$143,896 and likely will reach the \$160,000 goal for the year. Both SK districts are at 50% contribution. Canadians can get a tax receipt now for their donation. The postal strike at the end of the tax season and LCIF staffing delayed posting and affected SK donation numbers.

Long Range Planning Chair - PID Pat Vannett – The goal is to create job duties and responsibilities for state and provincial representatives. LR Planning will be meeting with the new state and provincial representatives, incoming GAT and DGs.

New Voices Chair - Lion Crystal Dueker — There has been an increase in women in Lions. **Pin Chair** - PDG Terry McAleese — no report —

Public Relations/Marketing/IT Chair - PCC Kevin Bean - No report.

CC LeeAnn reported the marketing and IT/calendar positions have been separated into two positions. PDG Don Morris was elected to the calendar/IT chair position. IT will be part of the GAT team in the future. District IT coordinators need to be part of the MD team.

Marketing – Currently there is no chair for the 2025/2026 year.

Youth Camp and Exchange - Lion Darryl Oster – It is recommended that next year's chair attend the camp this year. Twenty-five are registered for camp with a potential of thirty to forty campers. This is the first time the camp has opened internationally since COVID. Thank you was expressed to Ken and Donna Wetz. 5NE is responsible for the 2026 youth camp. The camp is scheduled for July 6-12, 2025 in Northern Saskatchewan.
