New Business

a. Endorsement for PCC John Emmett as International Director Candidate DG LeeAnn Haisch moved to endorse PCC John Emmett as a Lions International Director Candidate. DGE Dennis Bohmont seconded the motion. PCC John Emmett gave a summary of his Lions history. He looks forward to serving at the international level and can bring a rural perspective to the board. Paper Ballots were handed out to certified delegates. PIDs Pat Vannett and Robert Littlefield counted the ballots and compiled the results.
PID Pat Vannett reported that all 53 certified delegates cast a ballot and that by

PID Pat Vannett reported that all 53 certified delegates cast a ballot and that by a majority vote, PCC John Emmett is endorsed by MD5 as a candidate for International Director.

b. Vote on Proposed Constitution Amendment

PDG Rob Hill reported for the Constitution and Bylaws Committee. He explained there were some changes in the numbering because of changes that were made to align with the International Constitution and Bylaws. The changes were drafted by the Constitution and Bylaws Committee and presented to the Council of Governors who then approved the proposed changes. The first proposed change addresses who will fill the VCC position. The second proposal expands who can run for the State/Provincial Representative positions. The change is moving from two to four years to give a wider selection of PDGs to run for the positions, so it is a five-year span, which includes the current year DGs. A comment was made from the floor that the VCC position should be opened up to

the IPDG first and then if they don't want to run then PDGs would be considered. PDG Rob explained that the only change at this meeting is to change it from two to four years. If members wish to have other changes considered, they will need to submit a resolution to the Council of Governors for consideration. The amendments take effect at the close of the convention.

Paper ballots were distributed to certified voting delegates with the following proposals. PIDs Pat Vannett and Robert Littlefield counted the votes and compiled the results.

Current Constitution

Article VI Sec 2 – change who will fill the MD5 Vice Council Chair position.

Article VI

Section 2. OFFICERS

The officers of the Multiple District shall be:

B) The Vice Council Chairperson of the Council, who shall be the immediate Past District Governor of the District in the state or province hosting the next Multiple District Convention. The Vice Council Chairperson shall fill the position of state or provincial representative for their respective state or province.

Proposed change

Article VI. 2. B

B) The Vice Council Chairperson shall be filled by the state or provincial representative of the state or province hosting the next Multiple District Convention.

PID Pat Vannett reported the amendment to the MD5 Constitution and bylaws were adopted by the voting delegates as follows: 53 ballots cast with 48 in favor, 4 opposed, 0 abstained and 1 spoiled ballot.

Article VI. Sec 1 B – Change the number of PDGs that can run for the State/Provincial Rep. positions.

Current Constitution

Article VI. 1. B

Three immediate Past District Governors and/or Past District Governors from the previous two years, which number cannot exceed one-half of the number of District Governors who shall have been elected by the voting delegates of their respective province or state at the Multiple District Convention meeting of the previous fiscal year. There shall be at least one (1) immediate Past District Governor or Past District Governor from the previous two years each from Saskatchewan, North Dakota, and South Dakota. The State or Provincial Representatives shall serve for a one-year term only and cannot serve in that capacity again.

Proposed Constitution Change

B) Three immediate Past District Governors and/or Past District Governors from the previous four years, which number cannot exceed one-half of the number of District Governors who shall have been elected by the voting delegates of their respective

province or state at the Multiple District Convention meeting of the previous fiscal year. There shall be at least one (1) immediate Past District Governor or Past District Governor from the previous four years each from Saskatchewan, North Dakota, and South Dakota. The State or Provincial Representatives shall serve for a one-year term only and cannot serve in that capacity again.

PID Pat Vannett reported the amendment to the MD5 Constitution and bylaws were adopted by the voting delegates as follows: 53 ballots cast with 48 in favor, 4 opposed, 0 abstained and 1 spoiled ballot.

Moved by PCC Kevin Bean and seconded by VCC Scott Hildre to destroy the ballots for PCC John Emmett endorsement and Constitution and Bylaws changes. Motion carried.

- (1) North Dakota Rick Stark reported that he was elected as the North Dakota Representative
- (2) Saskatchewan DGE Heather Vermeersch reported that Don Morris was elected as the Saskatchewan Representative
- (3) South Dakota DG LeeAnn Haisch reported that Dave Pigors was elected as the South Dakota State Representative

Convention Host Update/Announcements – Lions KayLee Bourquin reported for the committee. She thanked the Lions and the convention committee for a successful convention. She announced choir practice at 3:00 and cash bar at 5:00 prior to dinner at 6:00 where 3rd IVP Mark Lyon will be the guest speaker. They provided one free drink ticket for veterans.
