District Administrator Having Trouble Reporting

in MyLion?

Dear Lion,

Just a reminder that all Lions clubs, districts and multiple districts with annual gross receipts less than \$50,000 who are not otherwise required to file Forms 990 or 990-EZ must file the e-Postcard (also known as 990-N). If your Lions club, district or multipole district has a foundation, which is a separate legal entity, the appropriate form will need to be filed as well.

It's NOT You!

Since the new system has been implemented, there have been countless errors in addition to the pandemic erupting business. Phone calls have been swerving back and forth with this issue.

For whatever reason, the internet is temperamental in not wanting to recognize the server. One day it will accept and one can log on and the next day it will not!

This is what they have discovered: After trying with one internet system to log in, and it does not work, try another. For example, if first using google.com and it does not work, try using Firefox,



Microsoft Edge, or Brave.

One of those internet systems will get one to the site needed to record Monthly Membership Reports or Service Activities. There may be others of which one may be aware.

Presidents, secretaries, or other identified Lions with the access, use the District Directory and call *Our Friends at Lions Clubs International Headquarters.* Locate this information on pages 54 and 55 of the 2020-2021 District Directory District Governor James Douty.

Activity vs Administrative: Lions Clubs Accounts

B. USE OF FUNDS POLICY

- 1. **General Policy on Funds Raised from Lions Clubs Activities.** Funds raised from the public must be used for the benefit of the public and community in which the Lions Clubs serve. The International Constitution and By-Laws and Articles of Incorporation (the "governing documents") provide that chartered Lions clubs shall be not-for-profit of the individual club or its individual members. Consequently, no part of the net earnings of funds raised from the public shall benefit any individual Lions member, or other private individual or entity. These policies are intended to provide guidance for clubs to meet the purposes of the International Association of Lions Clubs. Key in determining the proper use of funds is considering transparency to the public and developing trust from the community in which the Lions operate. How Lions use funds must meet the legal and tax requirements for the local jurisdiction in which they operate.
 - **a. Definition of Public/Activity Funds.** Funds raised from the public are the net earnings of income raised from activities open to the public, public contributions, bequests and money accumulated from invested public funds.
 - **b. Definition of Administrative Funds.** Administrative funds are contributions from Lions through dues, fines, advertisement revenue, rental fees and other individual Lions contributions. These funds may be used for either public projects or for internal Lions use such as meeting and convention expenses, incorporation fees, audit fees, newsletters, bulletins and other club and/or district operating and administrative expenses.
- 2. **Direct Expenses of Fundraiser.** Direct Expenses of a public fundraiser may be deducted from the proceeds of the fundraiser to replenish the administrative funds used to hold the fundraiser.









USE OF FUNDS GUIDELINES

These guidelines are intended to assist Lions members, clubs, and districts (single, sub-, and multiple) in following the Use of Funds Policy adopted by the International Board of Directors. These guidelines are a supplement to the Use of Funds Policy and are not intended to replace the policy adopted by the International Board of Directors. Lions are encouraged to review the described Use of Funds Policy in detail and may be found on the Lions Clubs International website www.lionsclubs.org or by contacting the Legal Division at legal@lionsclubs.org or by calling 1 -630-203-3847. It should be noted that these guidelines are not intended to constitute legal or tax advice. The following questions and answers are typical questions and answers for non-profit organizations but may not be accurate under every local law which may have different requirements. For additional questions and advice about the use of funds and the laws in your jurisdiction, please consult local legal counsel or tax professionals for advice.

Property

- 1. A Lions Club raised funds from the public to build a community center. May the building be used for Lions meetings as well as for the community? Yes, so long as the building is primarily used for the community, the club may still use the building for its own meetings.
- 3. The Lions Club owns a building and permits the local Boy Scouts (or other community related group) to use the building free of charge. May we use funds from the public account to clean the building after the use by such organizations? Yes, you may use public funds to offset direct expenses for the public use of the building.
- 4. Our Lions Club owns a multi-use building where we hold public fundraisers, donate use of the building for other community organizations, charge rent for private events and hold Lions meetings. Can we use public funds to offset Page 2 of 6 Effective February, 2012 the cost of maintenance and upkeep? Yes, you can use a pro-rata share of the public funds related to the percentage of the use of the building by the public.
- 5. The Lions Club maintains a public park. May we use public funds for maintenance of the public park? Yes, because the park is for the use of the public, public funds may be used to maintain it.

Benefits to Lions or Family Members

- 14. A member of our Lions Club recently lost their house due to a fire. May we use public funds to assist him? Use of public funds to benefit a member of the Lions club is not permitted. However the individual club members may donate to the member personally to assist him.
- 15. The sister of one of our Lions Club members recently lost their house due to a flood. May we use public funds to assist her? Use of public funds may not be used to personally benefit a Lion. So long as the member will not personally receive a financial benefit from the transaction, a family member who is not a dependent may be eligible to receive public funds from the Club.
- 16. Our town recently suffered a devastating flood and many of the Lions as well as the community at large suffered extensive loss to their homes. May we use public funds to assist the community which would include affected Lions? Use of public funds may be used to assist the community including affected Lions members in the case of disasters so long as the members meet the same eligibility criteria established for the disbursement of funds and assistance.
- 17. We have a member of our club that needs a heart transplant. May we hold a fundraiser in his name to raise money for the financial hardship of the medical procedure? No, this is considered a private benefit to a member. However, individual club members may donate to the member personally to assist him or ask others to donate personally to him.

Public Fundraisers vs/ Private Lions Fundraisers

- 20. Our Club is holding a Golf Tournament and we are selling tickets to Lions and the public. Lions receive a blue ticket and members of the public receive a yellow ticket. May we use the proceeds from the ticket sales to the Lions (as evidenced by the blue ticket) for our administrative funds? No. Once the event is open to the public, all the proceeds are considered public funds.
- 21. We are having a Lions dinner open to all Lions Clubs in the District. May we use the proceeds from the sale of the tickets to the dinner for our administrative funds? Yes. As the event is limited to Lions members, the proceeds may be designated as administrative funds as well as public funds.
- 22. Our Lions Club is working the vending area at the local football game and is getting paid a percentage of the sales by the stadium. May we designate our payment as administrative funds? Yes, so long as this is the agreement between the stadium and your club and no Lions name or logo is displayed in working the event through signs or clothing.
- 23. May our Lions Club accept a personal bequest from a member of the public (non-Lion) to be designated administrative funds? Yes, if the bequest was received with specific directions to be used for the administrative purposes of the club.

Clubs should not use the EIN assigned to the PA State Council of Lions Clubs and/or Lions Clubs International.

CBL Amendments to be Voted Upon at Special Election in November

Pages 13 and 14 information packet for the Nov. 8 Special Election during which two proposed changes to the MD-14 CBL will be considered. This information was previously sent to your 2020-2021 District Governor with the request it be forwarded to club presidents and secretaries. To help assure maximum exposure of the material, we are now backing that distribution effort up with this email to you as a PDG.









The Special Election, due at the November State Council Meeting on November 6 thru 8, 2020 will still take place.

The necessity of the **Special Election** is to complete the two outstanding Ballot Questions, originally scheduled for a vote at the May 2020 State Convention.

The Council of Governors, at a Zoom Meeting on Sunday, September 20th, approved the Multiple District hold on Electronic Election and selected Election Runner as the application of choice.

This letter will now serve as the official notice of the manner and timing of an Electronic Special Election, using electionrunner.com to be conducted by the MD14 Lions of Pennsylvania on Sunday, November 8, 2020 between the hours of 12 noon and 8:00 p.m.

An election packet will be mailed to each District Governor in time for inclusion in their newsletters and for distribution by their District Secretary/Certification Chair to Club Presidents and Secretaries containing the following documentations to guide them through the process:

- 1. **Election Process:** sets for the steps and timing of the election to ensure its successful completion.
- 2. **Delegate Collection Spreadsheet:** an excel spreadsheet to enter the Delegate names, member numbers (for certification purposes only) and email addresses to be uploaded to electionrunner.com.
- 3. Official Delegate Certification Form: each club secretary and/or President must complete and return this and the Delegate Collection Spreadsheet to the State Office, preferable by email, by Friday October 23, 2020.
- 4. Sample Letter to Clubs including the Potential Delegate Count: showing simplified process and the number of delegates that each club in each District is entitled to
- 5. Ballot Questions: copies of the two ballot Questions.
- 6. Unpaid Dues Schedule: Dues must be paid to Lions Clubs International no later than Monday, October 14, 2020 for a club to be entitled to have their own nominated delegates to vote in this election. (Each District received their own District Recap Report to be included in this packet).

It is very important that all delegates have a correct email address as the election will be conducted electronically (no paper ballots will be sent.)

It is especially important that the timeframes set forth in the Election Process document are adhered to for the election to be complete and it is imperative that Clubs notify their delegates of this process so they know what to expect.

Once all delegates have been certified by the Districts and sent to the State Office, 17 sub elections will be set up and delegate information uploaded into electionrunner.com.

On Sunday, November 8, 2020, an Invitation to Vote will be issued to every certified delegate from electionrunner.com and will contain:

Ballot Questions

Ballot Question 1

The following resolution concerns amending the International Association of Lions Clubs Multiple District 14 (PA) Constitution. To be adopted, this amendment to the Constitution requires an affirmative vote of two thirds (2/3) of the certified delegates casting a vote.

A Resolution to provide additional language to Article VII, Section 4, Council Person.

The Resolution adds language to clarify:

- 1) The term of office for the Council Chairperson
- 2) The selection process for appointing a replacement in the event of a vacancy in the Council Chairperson position, and
- 3) The council chairperson rotation

BE IT RESOLVED, that effective July 1, 2021, Article VII, Section 4, will read as follows:

"Section 4. COUNCIL CHAIRPERSON. The Chairperson of the State Council shall be the Immediate Past District Governor who had served in the capacity of ice-Chairperson during the preceding year, who for the year 2020-2021 shall be from Sub-District P. The Council Chairperson shall serve for a one-tear term only and cannot serve in that capacity again.

In the event, either before or after becoming the Chairperson, if unable to serve, or having accepted, resigns or dies, then the District Governor or that sub-district shall appoint a Past District Governor who is resident in and a member in good standing of a Lions club in that sub-district to serve out the term of office. If no Past District Governor from the sub-district is willing to serve, then the sitting Council of Governors will appoint a Past District Governor from the two preceding State Councils who is resident in and member in good standing of a Lions Club in Pennsylvania to serve the remaining term of office. The normal Council Chairperson rotation will resume when the replacement Council Chairperson's term of office is completed.

Ballot Question 2

The following resolution concerns amending the International Association of Lions Clubs Multiple District-14 (PA) By-Law to adopt this amendment to the By-laws requires an affirmative vote of the majority of the certified delegates casting a vote.

A resolution to provide changes to Article VI, Section 2. Distribution of Funds.

The resolution modifies the distribution of the Current & 16 per-capita dues as follows, starting July 1, 2121:

- Eliminated the "Promotion Fund" of \$0.35
- Increases the "State Council Administrative e Fund" from \$2.50 to \$3.00
- Increases the "Sub-District Administrative Fund" from \$8.50 to \$9.60
- Replaces the "PA News Publication Fund" with the "Communication/Web/Pride Fund" and reduces the allocation from \$1.50 to \$0.25.
- The Resolution DOES NOT INCREASE or DECREASE the current overall dues.

Be It Resolved, that effective July 1, 2021, Article VI, Section 2. will read as follows:


