Item A: Whereas PID Mark S. Lyon is the current 1st International Vice President and will be expected to advance as the next International President:

Be it hereby resolved that the members, Cabinet and Executive of Lions International District N 1 will hereto lend their support to PID Mark S. Lyon to be the next President of the International Association of Lions Clubs.

Bylaws

Amendment 1 – Convention Registration Fee

Whereas Article VII (Convention Fund), Section 3 of the District N 1 Bylaws states that “Every Lion attending must pay a **\$5.00** registration fee.” And that, “This registration fee must be attached to and form part of the price of a Hospitality Book.” and,

Whereas this **\$5.00** is not in keeping with the significantly increased costs associated with organizing a District Convention,

Be it hereby resolved that the District Convention registration fee be increased from **\$5.00 to \$10.00** and that the language of Article VII (Convention Fund), Section 3 of the District N 1 Bylaws be amended to read as follows:

Section 3. FEE COLLECTION. Such fee as the District Governor shall set may be collected, under procedures set by the District Governor, from each delegate, alternate, and guest attending the district convention to defray the actual cost of convention meals and entertainment. Every Lion attending must pay a **\$10.00** registration fee. This fee must be attached to and form part of the price of a Hospitality book.
