Please Join Us In Las Vegas



Diabetes Awareness Message

So you are diabetic, does that mean no more Easter candy for you? Does it mean no birthday cake, Christmas cookies, stuffing or mashed potatoes? Some people would say that you can't have any of these things anymore. No more bread, pasta, cereal, candy, only vegetables and protein for you now.

Well, while a good balanced diet is a requirement for all of us, not just those of us with Diabetes, there are always exceptions to the rules. I know that when Alex was first diagnosed, the nurse told him to choose his carbs wisely. She explained that Rice Krispies were mostly air and would not stay with him so try to eat a cereal with more fiber or substance to it. We were just at a luncheon and melon was served before the main course. It was noted that the melon is not on the approved fruit list for diabetics as there is little fiber. In fact there are many fruits that are on the avoid list. We need to remember that fruit has a lot of sugar and therefore carbs. Alex was also told that he could eat carbs in moderation and isn't that true of all of us. If we were all able to eat everything we wanted just in moderation then most of us would not have a real problem with our weight. One small roll is fine occasionally, half a loaf of bread every day, not! A small piece of cake for a special occasion, good, eating the large corner piece with all the frosting a few times a week, not so good.

We all have to read the labels on our food. Actually, measure our portions and make sure that vegetables cover half of our plate at any meal. Sometimes we think we are eating in a healthy way only to have a dietitian look at our food log and start cringing. Vegetables are good but not when covered with cheese or butter, a baked potato is ok if you eat a half and do not put on butter and sour cream, and watch those salads because some of them have more calories and carbs than a sandwich. We should all carefully check those carbs and the fat content of our foods.

Exercise is the other missing component in most of our routines. Even walking 15 minutes a day will help you to feel better and control your blood sugar. With the weather finally improving, get out and walk a bit. Walking can also help with your stress level and stress is not good for your blood glucose level.

As with anything else, moderation is key. It also does not hurt to deny your cravings occasionally.

Remember to send me your Diabetes activities and to continue to be aware of what you eat.

Please take the time to complete the short quiz on the next page of this newsletter to help you determine if you may be a high risk for diabetes. This doesn't mean you have diabetes, only that you might need to talk to your doctor the next time you see them. It is always good to be prepared and aware.

Lions Camp Badger Opens New Program

Many of us have experienced the joy and calm that comes from a peaceful hike in the woods. The chirping of birds, the gurgle of water in the stream, the feel of the warm sun on our shoulders...the wilderness offers a healing environment like no other. It is the perfect setting to gain a fresh perspective, a renewed hope, and skills to take on the challenges present in daily life. We find that when everyday distractions and disruptions are absent, we are able to focus on new opportunities and personal growth. That's what's so wonderful and powerful about nature!

In response to a growing need for mental health support for struggling teens, Lions Camp Badger is proud to offer a new five day program called Breakthrough Badgers. Designed for ages 13-17, Breakthrough Badgers offers a healthy, restorative atmosphere that enables campers to develop tools and strategies that can be used in home and school settings once camp is over. Lead by professionals in fields of special education and social work, the goal of Project Breakthrough is to empower each camper with strategies that will support them in positive choice-making and healthy mindsets. It is our hope that these teens will leave Project Breakthrough knowing how to write the next chapters of their lives so as to make a positive difference in their futures.

Held from July 15-19, Breakthrough Badgers will enjoy typical camp activities that include boating, swimming, fishing, music, hiking, campfires, and arts and crafts. Added to this will be problem solving, calming techniques, yoga, mindset/goal setting, stress and crisis management, inspirational speakers, and team building. The program is highly individualized to offer each camper the best opportunity for success. Campers who have experienced emotional and/or behavior challenges are welcome here with or without a formal mental health diagnosis. These are the teens who may be "at risk" and need to learn the coping skills that will support them. Campers can attend Breakthrough Badgers on a sliding fee scale that is designed to fit their family budget. It is our hope and our goal to not turn anyone away due to financial need. Camperships and donations are gratefully and sincerely appreciated as we get this new program off the ground.



LCI Dues Credit for Dropped Members Info

Dear Lion Leaders,

Starting on June 30, 2018, **dues credits for membership drops will <u>not</u> be issued** after the release of the semi-annual billings on July 1 and January 1.

In the past, Lions Clubs International has given clubs a grace period in January and July to adjust their club rosters and receive a credit for unreported membership drops. This practice has been a courtesy extended to clubs by Lions International despite rules governing the practice in Board Policy. The board of directors recently decided that enforcement of existing policy is necessary in order to be in compliance with Board Policy.

This will also provide greater alignment with district billing and create more accurate reporting that better reflects true membership growth. We realize that this will have an impact on some clubs, so we would like you to help them prepare for the upcoming billing cycle.

Here are a few best practices that can help you prepare your clubs for their July dues billing:

- Remind club officers to update their membership rosters using MyLCI or their regional reporting system.
- **Encourage** club officers to submit their membership roster to MyLCI or their local reporting system prior to **June 30, 2018 CDT**.
- **Inform** current and incoming leaders that membership dues credits will no longer be issued.



From Malone Lions Clubs

Malone Lions Club Random Acts of Kindness Program (2nd Year)

At 5:00 PM on Wednesday, December 14th, 2016 The Malone Lions Club announced the launch of the 1st ever "Random Acts of Kindness" Program. For over 60 years the Malone Lions Club has historically given funds to larger "group/organizational type" projects (over \$400,000 since the club's inception, December of 1949).

While all members of the club are expected to work for the Malone Lions Club foodstand at the Franklin County Fair, the distribution of funds raised by the Foodstand has been, almost exclusively, determined by the Board of Directors.

On Dec. 15, 2017 the second year of the program was launched. All Lions members in good standing who helped raise money for the club at the fair stand were again given \$50 to use to perform Random Acts of Kindness in our community. The purpose of the Program is "...to give each member a personal say in how some of the money that they have helped raise is donated in our community." It is our way of thanking the community for supporting our club and our annual foodstand at the fair."

The reports are all in. The Random acts of kindness funds (\$1,400 in all) were distributed (anonymously) to: a 91 year old widow living on social security who needed help with her heating expenses, an elderly lady who cried when the money was handed to her, a ninth grade student who lost her mother, and whose family was already facing financial hardship, Constable Veteran's Committee, 3 members pooled their gifts plus the Lions Club added \$200 to a fire victim who lost her house and all belongings, a father bringing up 3 sons alone, one of them very sick, a young man battling cancer and depression, an elderly man living alone on a very small social security income, a woman who needs help with medical expenses, a car accident victim, a high school student living in near poverty who wants to go to college, three children who lost their mother just before Christmas (plus the Club added \$200 to this cause), another fire victim, a couple who took in a woman in a wheelchair whose house had burned down, a young man who first lost his job at K-Mart and then lost his job at Yando's, and a woman who is struggling to make ends meet after her husband had a stroke.

One member on vacation, gave his \$50 to a homeless man sleeping on a bench in Florida. The man said no one had ever helped him like that before and this was the best Christmas present he ever got. Our Lion member felt so good about giving that he took another \$50 bill of his own money and gave it to a homeless woman who had all her possessions in a shopping cart. She immediately (after she was told this was "not a gimmick") said she was going to buy something to eat for herself and a friend who both stay in a vacant house.

Malone Lions Club President Tim Conners reported that 19 members participated in the program, donating \$950, plus the Club added \$400 and one member put in an extra \$50 bringing the total to \$1400. He stated that the second annual Malone Lions Club Random Acts of Kindness program has become and will continue to be an annual event.

From Long Lake Lions Clubs

On Sunday, March 18th members of the Long Lake Lions along with help from community volunteers gathered at the Long Lake Town Hall to sort and pack Easter food baskets for distribution in the community. Thirteen families had an Easter feast delivered to their doors. Recognizing that not everyone is able to cook, the Lions Club also arranged through the Adirondack Hotel for hot meals to be delivered that day to others.

Lions are always looking for ways to help their community and welcome new members at any time. A special thank you to all our packers and delivery people – Lions Regina Dunn, Carol Inserra, Lew Plumley, Vickie Plumley and Robert Keough, Sue Kunzmann and community members, Ken Iffert and Barbara Keough.

**Please note: Although administered by the LHCS, this program is considered a local Club service.

Eligibility Criteria to be Considered:

- 1). Applicant must be unable to seek relief from other external sources such as insurance, Medicaid, government assistance, or the VA, among others.
- 2). Applicant must be unable to access financial aid from personal resources or other family members.
- 3). Applicant's income level should be at or below 200% of the poverty level
- 4). Sponsoring Club must interview applicant for eligibility either in-person or by phone to: verify information given, with the hope that this will personalize the program for the recipient; allow the Club to verify information; and offer the Club local recognition.
- 5). LHCS reserves the right to determine final eligibility.

Order Submission Instructions:

1). A completed eligibility form signed by a Club representative, a completed recipient application, the indicated model and quantity of hearing aid(s) requested, and a check from the Club's share of covering the cost of the units.

***Contact the Hearing Society for pricing before remitting a check.

2). LHCS will in turn review the form for completeness, deposit the Club's check, and include a check from the LHCS with the order to the manufacturer.

What to do in Case the Club Cannot Afford to Help the Person on their Own:

- 1). Please feel free to contact the Lions Hearing Conservation Society (LHCS) or any District officer for LHCS contact information.
- 2). LHCS will consider a cost-sharing partnership with the sponsoring Club so the eligible recipient can receive our help.

What About Professional (Audiologist) Services?

- 1). Historically, The recipient is responsible for any professional services, such as: a required hearing test, ear mold sizing, hearing aid fittings, etc.
- 2). We recognize that every situation is unique, so under exceptional circumstances, the sponsoring Club may wish to consider funding these or other professional services on the recipient's behalf and as part of the Club's assistance efforts.
- 3). If the sponsoring club cannot afford to do this on their own but feel the recipient has special circumstance sponsoring Club can contact the LHCS for possible assistance.

- 1). Recipient meets eligibility guidelines as judged by sponsoring Club
- 2). Completed and signed Recipient Application
- 3). Completed and signed Income & Asset Qualification form
- 4). Completed ordering form that includes a written statement from treating audiologist stating hearing aid(s) are required treatment, quantity needed, and recommended Oticon model number.
