CABVI donates to the Beacon of Hope Outreach Ministry - PDG Paula Flisnik

Arch 24, 2018, United Nations Lions Day witnessed the joining of service partners; the Central Association for the Blind and Visually Impaired (CABVI) and the Beacon of Hope Outreach Ministry (BOHO).



PDG Paula Flisnik, CABVI's Director of Community Relations, and Lion Lady Celestina Ekezie, NYS Barahona Lions Club/BOHO Founder and CEO met and quickly realized that their conversation that day would be the first of a continuing relationship.

Lion Lady Celestina described BOHO's medical and educational services. PDG Paula replied "I can help with providing the Nigerians with donated items."

PDG Paula consulted with her CABVI colleagues. Nearly 700

Lions glasses were donated along with magnification devices, vision screening materials, nitrile examination gloves and pencils. These donations will be used for the Adinije Memorial Medical Mission in January 2019.



Following PDG Paula's contributions, the Marcy Telephone Lions Club (MTLC) has collected shoes and sneakers accompanied by a financial donation to the Beacon of Hope

Outreach Ministry. MTLC visually impaired Lions bring aid to visually impaired Nigerians. FANTASTIC!

The donated items are being shipped to Nigeria in multiple lots over four months. This allows the organization to raise additional funds to cover transportation costs, facilitate shipping logistics, customs clearance, and provide land transportation to inland sites where BOHO's events will be held.

Nearly 6000 people from rural communities in Nigeria will receive assistance! Participants will undergo medical exams, receive prescribed medications, attend public health awareness and receive health-related educational materials.

The Beacon of Hope Outreach Ministry's future plans include building a rehabilitation and wellness center in Owerri, Capital of Nigeria.



NICK'S FIGHT TO BE HEALED FOUNDATION



Nick Cammarata was a healthy young adult who loved to swim, read, build legos, and play videogames - just like any other 12 year-old boy. In June 2008, he developed a simple rash, which his family thought was nothing more than a side-effect

to the antibiotic he was on. Nick went back and forth to the doctor, and trip after trip nothing was determined. After these numerous trips to the doctor, he got a blood test. One month later, on July 4, Nick was diagnosed with Acute Lymphoblastic Leukemia (ALL). Nick's type was T-cell, which is a harder form to cure. Nick went through 4

grueling months of intense

chemotherapy. After the



chemo, he was in remission, but now needed a bone marrow transplant.

On October 26, 2008, Nick passed away from complications from his treatment.

The Cammarata family has started **Nick's Fight To Be Healed Foundation** to reflect Nick Cammarata's values and personality by helping other patients with blood cancer his spirit lives on.

The mission of Nick's Fight to be Healed Foundation "is to support pediatric blood cancer patients as well as serve the young adult blood cancer community. We strive to improve quality of life by promoting well-being, reducing stress within the entire family, and providing resources to help children with blood cancer lead fun and fulfilling lives."

Nick's parents, Janine and Lucas Cammarata, are President and Vice-President of **Nick's Fight to be Healed Foundation**. Together, with the help of a Board of Directors they support young adults to have an easier experience battling their sickness. Together, they experienced first-hand how the battle with cancer changes a family, taking a toll on everyone involved. They understand the financial struggle of making ends meet while a family member is sick. They understand the need to spend time with your child in the hospital while maintaining a full time job and taking care of a family at home. That is why they want to reach out to other families who are in the situation they were in. They want to lend a hand.

The Story Behind Nick's Logo & Slogan

Nick loved all things medieval - dragons, knights, castles. He loved reading fantasy stories, especially King Arthur. The dragon in the logo comes from one of Nick's dragon books. It is a wyvern, a legendary winged creature with two legs and barbed tail often found in medieval heraldry. The shield and sword was thought up by Lucas, Nick's father, which matches the memorial he placed at Nick's site. Nick chose the red and black colors and the "Fight to be Healed" slogan while friends and family were raising money to help with his medical bills. Designed together, the logo represents the spirit of Nick that will shine through to other children defending themselves against cancer.

SERVICES OFFERED How Nick's Fight To Be Healed Foundation Helps

- **Financial Support** Providing financial assistance for pediatric blood cancer patients to help with bills, food, gas & other basic essentials families need to help them get through this time.
- **Comfort Bags** Providing the teen comfort bags to pediatric blood cancer patients (ages 10-25). Comfort bags include fun distractions and things to do such as books, DVD's, music, videogames,

cozy socks, new clothes or toys. Each comfort bag is personalized to fit the needs and interests of the patient at hand. They work with the clinic's Child Life Specialist filling out a survey so the foundation

Child Life Specialist Support - This position, along with many others at The Melodies Center for Childhood Cancer at Albany Medical Center is funded solely by donations and grants. This position is so vital and positive for pediatric cancer patients that it is part of the Foundation's mission to help fund it.

Some of their responsibilities include:

- Planning and implementing therapeutic programs and activities for young adults.
- Providing developmentally appropriate information about their illness and procedures, as needed, as well as providing support.
- Developing therapeutic and supportive relationships. with patients and families to provide advocacy and to initiate referrals to services within the hospital and community.
- Maintaining age-appropriate supplies in activity areas and exam rooms.
- Train, supervise and delegate work of volunteers and students who provide additional support.
- Educating patients' families and other medical staff about the psychosocial and developmental impacts of illness and health care experience.
- Working with different organizations to provide information and the best possible opportunities for children and their families.
- Provide fun distractions for teens and their families by purchasing tickets to their favorite sporting or entertainment events.

20W Environment Committee Environmental action ideas

Welcome to a new Lions year! It's time to get to work on new projects, or continue with ongoing projects leftover from previous years. I hope you had a nice summer and spent some time relaxing with family and friends.

Just to get started, I'm sure you're all aware of the term "climate change", but the whole topic may seem overwhelming



and hard to relate to on an individual basis. However, it really boils down to what you, your Club, and your community can do to try to mitigate the effects of climate change. The tried and true phrase "think globally, act locally" couldn't be any more true. One of the Lions Sustainable Development Goals is to ensure environmental stability. The questions boil down to **"What can I do?"** and **"What can my Club do?"**

Just for starters, think about the following ideas for your club. I'll provide more ideas next month, but these might just spur you on to come up with some interesting ideas of your own:

- Vacant lot or park cleanup—many communities have vacant lots or abandoned places that need cleaning up. Contact community governments and work with them to initiate a "cleanup day". This could be done on a continuing basis throughout the year and beyond.
- If there are community gardens in your area, find out if the administrators would be willing to set aside a section (or better yet, create a large, new section!) for your club to plant native plants for pollinators such as bees, butterflies, and birds. Even in your own garden at home, investigate planting native flowers, shrubs, and trees instead of cultivars. Native plants provide a wonderful opportunity for everyone, especially children, to learn about how plants and animals interact in the wild.
- Assess the needs of your community and find out how environmental challenges are affecting/impacting your local area. See if there are needs that are not being filled, and come up with plans to help.
- Work with your local school district or library to see if there are environmental education programs for children. Find out if your club could donate educational materials.

If you're going to work with local governments, do your homework and be ready to present workable ideas or solutions for community environmental issues. You may be acquainted with a council member who is concerned about the environment. Talk to that person to get suggestions.

What is MyLion?

MyLion is Lions Clubs International's new digital service platform for all Lions and Leos. MyLion is available in two formats:

- **The MyLion app is a mobile phone application** that you can download on your smart phone. It was gradually released starting in 2017 and is available everywhere outside of the European Union.
- MyLion on the web is the next major MyLion application and is a website that you will be able to access on any device with a web browser. MyLion on the web will be gradually released over the next few quarters.

When will I have access to MyLion on the web?

Over the next few quarters, Lions Clubs International will work with our Global Action Team leaders to gradually release MyLion on the web to ensure there is adequate time for testing and training.

Why are we gradually releasing MyLion on the web?

By gradually releasing MyLion on the web we can:

- Focus on one region at a time and provide advanced notice and support to MyLion users.
- Collect and methodically apply feedback.
- Ensure that every member has adequate time to learn the MyLion system before transitioning service activity reporting from MyLCI to MyLion.

Where should I report my club's service activities right now?

You should continue to report your service activities on MyLCI or your local reporting system until your region received MyLion on the web. We will communicate well in advance when MyLion on the web is available for you to test in your region.

Where can I learn more about the MyLion app and eventually MyLion on the web?

Our website <u>www.mylion.org</u> has tools, training resources, blog posts, and more related to the MyLion app. We will update it with content related to MyLion on the web as we begin to release the platform. <u>www.mylion.org</u> is your main, easy to navigate resource for all things MyLion.

When will the MyLion mobile phone app be released in the European Union?

We are working diligently with our partners in the EU to meet the requirements of the General Data Protection Regulation (GDPR). We will release the MyLion mobile phone app to European Union countries when we feel confident that the MyLion mobile phone app meets these requirements.

Lions Eye Institute at Albany, New York, Inc. Patient Referral Policy

Consultants' Management Services LLC (Physicians), Albany Medical Center and other Lions Eye Institute (LEI) approved medical facilities will accept patient referrals from Lions Clubs.

- 1. Lions may identify qualified individuals who appear to require subspecialty ophthalmologic services, who do not have private and/or governmental health insurance or the financial means to pay for such services, and who in the absence of assistance from the Lions are not likely to receive the needed ophthalmologic care.
- 2. Only the Club President and/or Secretary may make referrals. Referral is limited to these two individuals so that the club leaders will know who has been referred and can evaluate the appropriateness of the referral and monitor the progress of the referral.
- 3. Referrals must be made in writing. All forms must be <u>completely filled out and</u> <u>signed.</u> Patients must sign the HIPAA-compliant consent form allowing the exchange of medical information between the patient, Lions and LEI Physicians.

- 4. Referrals are limited to emergency, diagnostic, therapeutic and/or surgical care. Routine eye care is more appropriately handled by local eye care providers and shall not be referred to the Lions Eye Institute.
- 5. To qualify as a referred patient, the individual, agent, guardian or Lions Club must make reasonable attempts to obtain private, charitable, or governmental health insurance such as Medicare, Medicaid, Fidelis, etc. It is the responsibility of the Lions Club to make sure this has been done. Any financial assistance provided by the Lions Eye Institute shall be limited to a <u>maximum total of \$4,500 per patient</u>. Applicants who may require surgery and/or hospitalization must also apply to Albany Medical Center for financial aid by contacting AMC's Patient Financial Services department at 518-262-1981 or 1-866-262-7476.
- 6. Requests for information concerning a referred patient may be received. For ethical, legal and confidentially (HIPAA) reasons, information will not be released to a third party unless there is a signed release from the patient.



Below is a list of assistive devices available at many of LHCS of NYS's Loan-Out Centers. (Other equipment may be available upon request)

Pocketalker

Personal amplifier. Ideal for one-to-one Communication and TV listening.

Infrared TV Listening System

Wireless infrared amplification system.

Personal FM System

Wireless portable amplification system. Transmits up to 300 feet. Helpful for an individual or large group sutuation.

Amplified Telephone

Adjustable volume control with amplified ringer.

Amplified Telephone Ringers

Provides adjustable ring volume, frequency, and **p**itch tone.

Whistle Stop

Phone adapter to prevent feedback from using Telephone with hearing aid.

Digital Alarm Clock

Wake to an alarm, a flashing light, or a portable pillow shaker.

Alert Master

Uses a pillow shaker and a lamp flashing simultaneously to alert you to a smoke detector sounding, door knocking, telephone ringing, and alarm clock activation.

Cap-Tel Telephone

Telephone that has both amplification and caption capability

Personal Body Pager

Pager works with the Alert Master. You wear it to alert to sounds while awake.


