20-W and 20-Y2 PAST DISTRICT GOVERNORS

History Note: From 1921-22 to 1937-38, there was only one DG for the state of New York. In 1938-39, there were five DGs (N, Y, S, L, A). In 1949-50, there were eight DGs (N, E, W, Y, O, R, K, S). District Y2 was added in 1960-61, K2 in 1962-63 and E2 & R2 in 1973-74. In 2018-19, Y1 merged with Jefferson and Lewis counties from District W and was renamed District Y. The remainder of District W merged with District Y2 and called District W.

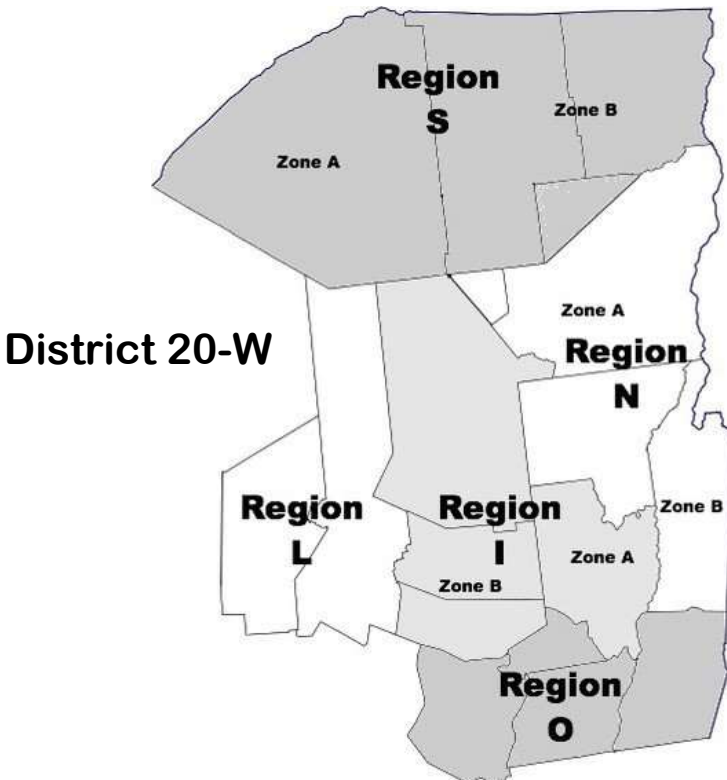
