Cabinet Business:

- **Secretary Report:**

CS Barbara Bentley presented the cabinet meeting minutes from the January 16, 2022 District Convention.

DG Michele asked for a motion to accept the Secretary's Report.

- A motion was made by RC Holly McConchie. Seconded by Lion Florence Brisee.
 - Motion unanimously passed

- **Treasurer Report:**

DG Michele presented the Treasurer Report that was submitted by CT Eric Unislawski (see attached). She reported that MD20 and LCI dues must be paid prior to the election at the state convention, otherwise those delegates will be unable to vote.

Also, we will be voting at the state convention on LCI dues increase, \$3, \$2, \$2, over the next three years.

DG Michele asked for a motion to accept the Treasurer's Report.

- A motion was made by RC/ZC Jim Winkler. Seconded by RC Holly McConchie.
 - Motion unanimously passed

- **District Governor's Report:**

DG Michele reported that the club reporting for membership was very good, and we still need

to work with clubs on service reporting.

Regarding the strategic plan, as of today she has received back 90 responses from the clubs.

DG Michele shared the list of clubs that ordered bunnies for LEI.

She reported that at the last Council Meeting, the following positions were filled for the Multiple District; GMT PDG Ed Stano, GST PDG Milledge Smith, GLT PCC Mark Whitney, Chair of Sargent of Arms PDG Milledge Smith and Chair of Elections PCC Mark Whitney.

She reported that at the recent Lions Day at the UN it was shared that there are 1.4 million refugees in Poland from the Ukraine. LCIF has a refugee link for donations for Ukraine. Kidsight is in 12 countries now. ID Gary Brown presented about the LCI diabetes initiative.

The district Policy Manual and By-laws are being worked on by PCC Mark Whitney, PDG Milledge Smith and DG Michele. They will be sent to everyone 30 days before the state convention and will be voted on at the convention.

The DG Testimonial will be on Friday, June 17th at the Vista at Van Patten Golf Club. It will be \$40/pp and there is a room block for \$149 at the Hampton Hotel on Plank Road in Clifton Park.

An email was sent to the clubs for recommendations for district awards and they are to have them back to DG Michele by April 1st so the district leadership can discuss them.

DG Michele is contacting the clubs in our district the have RJU's that are expiring.

Regarding the delegate forms for the state convention, DG Michele will be contacting all the Clubs to ensure they were received, either by certified mail or email. Delegates must be in person in Niagara Falls to vote on May 20-22nd. The hospitality suite for the ID candidates will be hosted in the Convention Center Friday from 7pm-11pm and Saturday from 9pm-11pm.

PDG John will be keeping his suite at the Hyatt as his "headquarters" for his campaign.

For the State Convention, PDG Ed & Lion Elizabeth Stano are Credential Chairs, Lions Holly McConchie & Florence Brisee Sargent of Arms, PDG Lettie Saheim nomination, PDG Joan Scott F Flag Ceremony and PDG Paula and Lion Gail Woodruff Voting & Elections.

DG Michele will be sending to the Region and Zone Chairs an email to develop an alert plan within their counties. It is hoped to have it completed by VDG Ricky Laurin's first cabinet meeting.

PDG Theresa Whalen informed us that they are going to be doing Lobby Day on May 2nd regarding hearing aid coverage.

On April 30th & May 1st our district will be doing a joint officer training with District Y. April 30th will be in Rome NY and May 1st in Lake George & hybrid.

DG Michele is encouraging the clubs to have their PU101s in by April 15th.

The International Convention is in Montreal in June. Information for registration is in our Newsletter. The Sheraton Center Hotel is the headquarter hotel for NYS.

The Club Excellent Award application is in the newsletter and all clubs are encouraged to fill it out. It needs to be back before August 1st.

NABA's Gala will be held on April 1st and they will be honoring the Lions of District 20W.

DG Michele is working with Lions Quest and St. Catherine's Center for Children to bring a new dimension to our district.

- **GRANTS:**

It was reviewed that in November the cabinet approved the NYS&BLF grant from Ogdensburg to be presented at the Foundation's January board meeting and the grant from Long Lake that was approved to be submitted at the Foundation's April meeting. Cambridge also had a grant they wished to submit once they were able. It was discussed that if both the Ogdensburg grant and Long Lake grant were closed before the NYS&BLF board meeting in August, both the Cambridge Grant and the Gouverneur club grants could be submitted (30 days before that meeting is held).

- The cabinet approved the submission of the Cambridge Lions club grant request to the NYS&BLF that was previously presented to the cabinet at the November cabinet meeting.

PDG Milledge Smith reviewed the NYS&BLF grant request from Gouverneur. The request is to fund two IV pumps for the Gouverneur Rescue Squad. The pumps cost \$1,050 each and \$200 to calibrate.

- The cabinet approved the submission of the Gouverneur grant request to the NYS&BLF board.

- **GMT Report:**

PDG Ed Stano reported that to date we have gained 87 members and lost 88 members.

He encouraged all clubs to add plus one to their membership.

Lion Dave Parmon suggested asking those that give money to support the Lions to join our clubs.

- **DGE Report:**

DGE Ricky Laurin discussed how kindness is synonymous with happiness.

He also reported that he has been attending visitations with DG Michele to get to know the clubs.

- **GLT Report:**

PCC Mark Whitney encouraged frequent, local orientations to progressively develop leadership skills and continued online learning.

He reported that we have 13 Certified Lions from 10 different clubs in 20W, but none have yet to be assigned to a club.

All club officers are encouraged to attend online learning courses that are free and will go on your Lions learning record.

He also encouraged all to attend the training on April 30th and May 1st.

It was reported that Lion Priscilla Laurin will be attending the Advanced Lions Leadership Institute.

- **GST Report:**

PDG John McDonald spoke of service being the foundation of our association and what drives our membership and from our membership is where we identify future leaders.

He stressed the importance of attending and sharing ideas about service at our cabinet meetings. Partnerships are a big thing we can use.

He reported that over 80% of our clubs are reporting service regularly.

PDG John and PCC Frank Blair have continued working on a new club in Burnt Hills/Charlton.

Bad weather caused a couple cancellations, but there are several people interested and they are being patient and optimistic that they will have a new club.

Committee Reports:

- **New Voices:**

Lion Rita Ware reported that she is not having any luck with people responding. She asked that

everyone try to choose a person in their club, young adult or woman, to submit their answers to the questions.

- **LEOS:**

Lion Joe Wagner reported that the Greenfield Lions are in the process of rebuilding their Leo Club.

There is a student at Siena College that is working on getting a club (OMEGA) at the college and currently has about 20 interested members.

PRESENTATION:

Presentation was given by Nichole Borchard about Double Up Food Bucks, currently working with the Albay-Troy Lions Club. (PowerPoint attached)

Committee Reports Continued:

- **Childhood Cancer:**

Lion Diane Lange has been in contact with the Ronald McDonald House and Melodies Center and reported that we can continue to help families with gas cards.

Leos clubs can be encouraged to make out generic cards for the children at the Ronald McDonald House of Melody Center.

Looking forward to working with the Patroons on assisting with a Childhood Cancer night.

- **Hunger:**

Lion Bob Maxum reported that a couple of clubs asked members to bring a non-perishable food item with them to the meeting for their local pantry.

The Clinton Lions are raising money for the local pantry from shredding paperwork at the clean up day in Clinton.

LEOS are also doing work with the food pantries.

- **Environment:**

Lion Greg Sheldon is reaching out to clubs to start a conversation on environment.

He is looking at things we can do in the district.

DG Michele noted that she would be sending an email to the clubs regarding St. Catherine's Center for Children looking for help with raised gardens to grow vegetables.

- **Hearing:**

Lion Dave Parmon spoke about the Hearing Conservation Society.

Four years ago, LCI cut off the affordable hearing aid program and in response to that change, district 20W made some changes and streamlined the application process.

He reported that the funding stream from recycling hearing aids has gone away. He is researching other companies that may recycle hearing aids to bring back that revenue stream.

He suggested that all clubs have a hearing chair. Once an application is received, the chair should meet with the applicant to vet them financially. If needed, the Hearing Society would get the forms from the club to chair to assist.

DG Michele noted that the Hearing Society has given a lot of money to our clubs and we should be supporting them. It was recommended that the club hearing chair attend one meeting a year of the Hearing Society.

PRESENTATION:

Presentation was given by Dr. Kathleen Braico with the Glens Fall group, The Adirondack Welcome Circle, that is sponsoring an Afghan family.

Alert Building:

PDG Rick Brisee spoke about the Alert Building that came about after Hurricane Sandy to respond to natural disasters or weather emergencies. It was intended for New York State, but has capabilities to respond to other parts of the country, as with Kentucky where \$15k in supplies were sent.

They are now working on replacing what went to Kentucky and have replaced about half already.

If help is needed, it must be requested by the club, not the community.

The "alert building" members will stick the trailer with what is needed that can be picked up. If the club can't pick it up, they will get the trailer to the area.

All clubs in the state have access to the Alert building.

There Alert Building is in Spenser/Ithica and they have a satellite on Long Island now. They are looking to a possibly have another satellite in the Saranac Lake area.

They are in the process of putting the items in the alert building on the state website and hopes to have that done by the state convention. Until then, if there is an emergency, contact the District Governor.

New Business:

DG Michele shared that there will be a special meeting of the Cabinet on April 20th to put Lion Priscilla Laurin in as 2nd Vice District Governor.

Lion Priscilla Laurin read the resolution from the Chazy Lions as nomination for Ricky Laurin as District Governor for 2022-2023. (See attached)

Lion Ricky Laurin read the resolution from the Chazy Lions as nomination for Priscilla Laurin as 2nd Vice District Governor for 2021-2022 (will be voted on 4/20/22) (See attached)

Lion Ricky Laurin read the resolution from the Chazy Lions as nomination for Priscilla Laurin as 1st Vice District Governor for 2022-2023 (See attached)

PDG Ed Pike read the resolution from the Galway Lions as nomination for Holly McConchie as 2nd Vice District Governor 2022-2023.

They will all be on the ballot at the state convention.

Having no further business to discuss, the meeting was adjourned at 1:34pm.



CABINET MEETING REPORT
MARCH 12, 2022 – SARATOGA SPRINGS, NY**

□ **ACTIVITIES/DONATIONS:**

- Eight club members join other community volunteers at our local *Food Pantry* on a monthly basis to distribute/package food to the food-insecure in our area. The distribution takes place in the parking lot of Annunciation Church in Clark Mills, NY. Patrons remain in their vehicles and food staples, produce and personal hygiene items are placed in their vehicles. On average 450 - 500 families (750 – 900 individuals) receive supplemental assistance each month.
- Conducted our annual *White Cane Fundraiser* at three locations in our village the week end before Christmas after a two-year hiatus due to COVID. It turned out to be our most successful White Cane fundraiser to date as thirteen club members solicited donations from village residents and visitors to our community.
- The *monthly collection of used eyeglasses* from containers previously placed at established businesses in and around our community continues. Every month we collect approximately 165 pair of glasses.
- Procured 600 *Diabetes Bookmarks* from LCI, affixed our club information and distributed them to clients at a recent monthly food distribution and to participants in a pre-holiday road race sponsored by our local Chamber of Commerce.
- Organized and staffed the majority of bellringers for the annual *Red Kettle Campaign* for the Salvation Army unit in our community. Because of this partnership, the local unit of the Salvation Army reimbursed our local food pantry for food supplies supplied to twenty-four underprivileged families from our school district this Holiday Season.
- *Recent donations* to charitable and other non-profit organizations totaling in excess of \$2,800. Included in these donations were: Kirkland Bloodmobile, Hospice, Utica Rescue Mission, MD-20 Alert, LCIF, Lions Eye Bank, our two Town Volunteer Fire Departments, Central Oneida County Volunteer Ambulance Corps (COCVAC), Rise Against Hunger (RAH) and our local Chamber of Commerce.

□ **FUTURE PLANS/ACTIVITIES:**

- Participate in our *Annual Community Collection Day* (May 14th); will be providing traffic control and sponsoring *commercial shredder* for resident's confidential documents.
- Continue *monthly collection of used eyeglasses* from previously established area business locations.
- In cooperation with Guidance Departments at three local area school districts, present six (6) *graduating seniors* with monetary recognition awards to assist in furthering their education.
- Continuing to join forces with other community volunteers in the *monthly distribution of food* to the food-insecure in our area at our local *Food Pantry*.




6. The grant will be used to purchase six IV pumps for the Gouverneur Rescue Squad. This grant will support the people of St. Lawrence County and Lewis County via Gouverneur Rescue Squad. The Gouverneur Rescue Squad currently does not have any IV pumps. They borrow IV pumps from the 5 hospitals closest to their Rescue Squad. They currently monitor IV drugs visually by drop numbers per minute. Having their own automatic IV pumps will secure patient safety. Since August 2021, the IV pumps are used on a weekly basis. The IV pumps are used for cardiac patients, sedation, high or low blood pressure and pain control. The Gouverneur Rescue Squad would like to purchase 6 refurbished IV pumps. Each pump is about \$1050.00 each and then a \$200.00 extra cost to program a drug library for each.



12. Having an IV pump on board a Rescue Squad vehicle will save lives. The possibility exists that patients may not receive accurate dosage of life saving medicine while being transport to one of the five local hospitals for treatment. The Gouverneur Rescue Squad currently borrows from area hospitals which lowers the number of IV pumps available at these hospitals. Sometimes transports can be hundreds of miles away going to Burlington, Vermont, Syracuse, Rochester, and Buffalo. This takes available manpower away from the area to address emergencies while they are in route to other hospital facilities.

14. This Lions supported program will help improve the health and well-being of our community members. The Gouverneur Rescue Squad is a vital service that outreaches to 5 different hospitals and impacts the lives of many in our community often on an emergent basis. The organization has 5 ambulances which have 21 EMTs and 16 paramedics. There are 8 volunteers within the squad. Local media will be present when the check is handed to the Gouverneur Rescue Squad. The Rescue Squad will put up a sign in recognition of Lions Club support.

6. What Project will the Grant be used for:

The Gazebo that is in Memorial Park in Cambridge has fallen into disrepair and is in desperate need of new flooring and supports, along with historically accurate lattice work, railings and roofing. Estimates to repair range near \$20k in repairs.

12. Impact on Community if Project is not Implemented:

Without the necessary repairs the structure risks further dilapidation. Located in Memorial Park, adjacent to the Cambridge Public Library, the gazebo acts as a bandstand for the Lions Summer Concert Series, a centerpiece to Christmas in Cambridge celebration and the Cambridge Lions Remembrance Trees, and as an outdoor learning room for our summer student programs with the Cambridge Public Library.

14. Describe How the Project will be identified as a Lions Supported Program:

The gazebo has been a prominent part of the Cambridge community since its inception at the Great Cambridge Fair from 1890- 1943. The Great Cambridge Fair was the precursor to the Washington County Fair and widely attended for many years. In 1974 as part of Cambridge's bicentennial celebration, the gazebo was moved from the old fairgrounds to "Lions Park" adjacent to Cambridge Central School. In 1984 "Lions Park" was updated with picnic tables and benches to allow more people to enjoy the nightly concerts at the gazebo. In 2012 the gazebo was moved to its current location in Memorial Park, since then it annually played host to the Cambridge Lions Summer Concert Series and the Holidays Eternal Illumination. A plaque will be permanently displayed memorializing the restoration and importance of the Gazebo in the Cambridge Community.



GAZEBO RESTORATION PROJECT

The gazebo was a prominent part of the Great Cambridge Fair from 1890-1943. The Great Cambridge Fair was the precursor to the Washington County Fair and widely attended for many years.

In 1974 as part of Cambridge's bicentennial celebration, the gazebo was moved from the old Fairgrounds to Lions Park adjacent to Cambridge Central School. The Daughters of the American Revolution (DAR) started the project and were soon joined by the Masons and the Order of the Eastern Star.


Thanks to community fundraising all arches and the posts supporting



them were saved, as was the cupola.

Over the years, the gazebo has been maintained by contributions from the Lions Club, the American Legion, the Boy Scouts and others. In 1984 Lions Park was updated with picnic tables and benches to allow more people to enjoy the nightly concerts at the gazebo. The Cambridge Community Band, oldest in America, has performed at the gazebo since 1890.





In 2012 the gazebo was moved to Memorial Park to make room for the CCS expansion project.

Located in Memorial Park, adjacent to the Cambridge Public Library, the gazebo acts as a bandstand, a centerpiece to Christmas in Cambridge celebration, and as a comfortable place to sit in the shade and enjoy the park.

The gazebo is woven into our community, whether it's serving as a cornerstone of our Memorial Day ceremonies, as a learning room for our students or as a backdrop for the Lions Club annual Trees of Remembrance.

Unfortunately it has fallen into disrepair and is in desperate need of new flooring and supports, along with historically accurate lattice work, railings and roofing.






