# CAMP BARK AND BREW BOOTH RENTAL TERMS AND CONDITIONS

**BARK AND BREW HOURS:** Saturday, March 28, 2020 from 10:00 a.m. to 3:00 p.m. Exhibitors/vendors will be able to move in from 8:00 to 9:30 a.m., Saturday, March 28, 2020. **EXHIBITORS/VENDORS MUST BE READY FOR THE 10:00 A.M. EVENT START.**

**EXHIBIT SPACE:** Exhibit spaces are **12 x 12 feet**. Exhibitors are responsible for their own tables, canopies, and all other equipment/materials they may require. Electrical power is not available. Exhibitors are responsible for their own generators, if power is needed. All canopies or tents must be securely anchored by sandbags or other appropriate methods.

**ASSIGNMENT OF SPACE:** District 2-T2 Lions Bark and Brew organizers reserve the right to assign space to rearrange the event and/or relocate any exhibitor to further the best interest of the event. District 2-T2 Lions Bark and Brew organizers shall assign space guided by exhibitor's priorities, by exhibit requirements, and by choice of locations.

**RESTRICTIONS:** District 2-T2 Lions Bark and Brew organizers may, at its sole discretion, prohibit, restrict and/or evict exhibits which are, in the opinion of District 2-T2 Lions Bark and Brew organizers, objectionable for any reason including, but not limited to, danger, noise and vibration, glaring or flashing lights, safety and method of operation, objects on display and/or method of display.
