## **KIWANIS DOERNBECHER CHILDREN'S CANCER PROGRAM**

OHSU Doernbecher Children's Hospital is a nationally recognized, regional pediatric treatment, training and research center, regularly caring for more than 250,000 pediatric visits each year with patients from every county in Oregon and Southern Washington. In the U.S., two children are diagnosed with cancer *every hour.* Kiwanis is partnering with the Doernbecher Children's Cancer Program for "A Future Without Children's Cancer."

### **CAMP MILLENNIUM**

Camp Millennium is a summer camp for children dealing with cancer, where "Laughter is the Best Medicine." The camp is a place where children touched by cancer can gather in a supportive environment and where they can simply be kids. It is a place where old bonds are strengthened and new ones created. Camp Millennium also provides a much-needed respite for parents as well as physical and emotional support for the campers without an added financial burden. Families are never charged for this wonderful adventure that can be extended into their everyday lives.

"Our purpose is to create a fun, safe, nonjudgmental environment in which children dealing with a cancer diagnosis have the opportunity to regain some of their lost childhood. We also strive to give children with cancer hope by offering opportunities for social interaction with other children dealing with the issues, thus creating a place in which children feel safe and secure in sharing their feelings and fears."

#### CAMP UKANDU

Camp UKANDU is the largest and longest-running provider of medically supervised camp available to children battling childhood and adolescent cancer in Oregon and, like all UKANDU programming, it's 100% free of charge.

Each summer, 132 children who have experienced a childhood cancer diagnosis and their siblings spend a week together, along with 110+ volunteers, playing games, climbing rock walls, riding horses, and 'just being kids!'

Camp UKANDU is a place where kids can grow and play; laugh and cry; and build what are, quite literally, experiences and memories of a lifetime.

When a family learns that one of their children is diagnosed with cancer, the last thing most of them want to do is send that child away from the family for a week. Time becomes more precious than it has ever been known. Parents are understandably covetous of the time and a future that is too often cut short. "However, our families recognize their children's health is reflective of more than their medical condition. Children need to socialize and play and grow. Camp UKANDU offers a place where Pediatric Oncologists and Pediatric Oncology Nurses are on staff 24/7, along with 100+ other volunteers to address the care and well-being of these kids. Many children are, in fact, on treatment while at camp. But no one lets that stop these kids from climbing four stories into the air on a rock wall; hopping on a smelly horse or cooking s'mores over an open flame.

"Our campers are patients, and siblings of patients, ages 8–18. In these formative years, 'normal' childhood development is a challenge. School studies, making friends, trying out for sports teams, joining activity groups and other clubs - these are some of the many ways most children seek to determine where they belong in a "normal" society."

## **BRIDGES OREGON**

Bridges Oregon is a non-profit 501(c)(3) organization created by Deaf individuals. Bridges Oregon provides high-quality services to enable the Deaf, DeafBlind, and Hard of Hearing to freely interact with mainstream society. 100% of all net proceeds go to programs designed to promote awareness of issues related to Deaf, DeafBlind, and Hard of Hearing communities.
