To Remember that in building up my business, it is not necessary to tear down another's, to be loyal to customers and clients and true to myself.

Whenever a doubt arises as to the right or ethics of my position or actions towards my fellow kind, to resolve such action against myself.

To Hold friendship as an end not a means. To hold that true friendship exists not on account of the service performed by one to another, but that true friendship demands nothing but accepts service in the spirit in which it is given.

Always bear in mind my obligations as a citizen to my nation, my province, and my community. To give to them my unswerving loyalty in word, act and deed. To give to them freely of my time, labor, and means.

To Aid my fellow kind by giving sympathy to those in distress, my aid to the weak and my sustenance to the needy.

To Be Careful with my criticism and liberal with my praise. To build up and not destroy.
