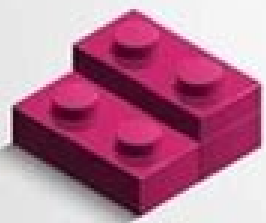

Put simply, your money should be working for you, not sitting in a bank account gaining pennies of interest when it could be earning much more.
